THIS SUBORDINATION AGREEMENT, made in the City of Chicago, State of Illinois this 23<sup>rd</sup> day of September, 2005 by LaSalle Bank, N.A., a National Banking Association organized and existing under and by virtue of the laws of the United States of America, and doing business and State of Illinois ("Bank").

Witnesseth

WHEREAS, the Bank is the owner of a mortgage dated March 15, 2003 and recorded April 28, 2003 among the land records in the Office of the Recorder of Deeds of Cook County, Illinois as document number 0311822074 made by Val Striev and Yana Striev, husband and wife ("Borrowers"), to secure and indebtedness of \$50,000.00 ("Mortgage"); and

WHEREAS, Borrowers are the owners of that certain parcel of real estate commonly known as 4240 N. Harvard Ave., Arlington Heights, IL 60004 and more specifically described as follows:

WHEREAS, BANK UNITED, FSB ("Mortgagee") has refused to make a loan to the Borrowers in the amount not to exceed \$250,000.00 except upon condition that the Mortgage be subordinate to said mortgage lien of Mortgagee.

NOW, THEREFORE, in consideration of the sum of Ten (\$10.00) Dollars in hand paid by each of the parties hereto to the other, and of other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged and in order to induce Mortgagee make the loan to Borrowers, it is hereby mutually agreed, as follows:

1. That the Bank covenants and consents that the lien of its Mortgage shall be subject and subordinate to the lien of Mortgagee's mortgage dated OCTOBER 03, 2005 reflecting and securing the loan made by Mortgagee to Borrower, in the amount not to exceed Two Hundred Fifty Thousand Dollars and No/100 and to all renewals, extensions or replacements of said Mortgagee's mortgage; and
2. That this Agreement shall be binding upon and shall insure to the benefit of Mortgagee, its successors and assigns.

IN WITNESS WHEREOF, this Subordination Agreement has been executed by the Bank of the date first above written.

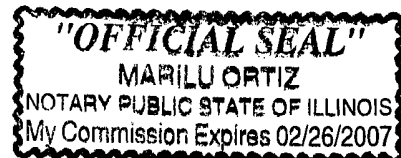
