In consideration of the sum of Ten Dollars (\$ 10.00) and other good and valuable consideration, it is hereby agreed by and between The Evangelical Covenant Church, an Illinois not for profit corporation at 5101 N. Francisco Avenue, Chicago, IL 60625 ("ECC") and North Park University, an Illinois not for profit corporation ("NPU") as follows:

WHEREAS, The ECC has a right of reverter (the "Reverter") of certain property owned by NPU pursuant to a deed originally executed by The ECC dated December 2, 1991 in the Cook County Recorder's office and recorded January 23, 1992 as Document No. 92044157 (the "Deed").

WHEREAS, the Reverter as stated in the Deed is expressly subordinate to certain Mortgages and Assignment of Rents given to secure certain loan obligations of NPU.

WHEREAS, The ECC is willing to give a subordination of its rights to the Reverter to certain additional loan obligations of NPU as more fully set forth herein.

NOW THEREFORE, the ECC does hereby grant a subordination of the Reverter as more fully set forth in the Deed to the following additional loan obligations of NPU:

- \$23,000,000 Illinois Development Finance Authority Variable Rate Demand
 Revenue Bonds (North Park University) Series 1999.
- 2) \$33,000,000 Illinois Finance Authority Variable Rate Demand Revenue Bonds (North Park University) Series 2005.
