5. Property Insurance. Borrower shall keep the improvements now existing or hereafter erected on the Property insured against loss by fire, hazards included within the term "extended coverage," and any other hazards including, but not limited to, earthquakesand floods, for which Lender requires insurance. This insurance shall be maintained in the amounts (including deductible levels) and for the periods that Lender requires. What Lender requires pursuant to the preceding sentences can change during the term of the Loan. The insurance carrier providing the insurance shall be chosen by Borrower subject to Lender's right to disapprove Borrower's choice, which right shall not be exercised unreasonably. 4. INTEREST RATE AND MONTHLY PAYMENT CHANGES

(A) Change Date

The initial fixed interest rate I will pay will change to an adjustable interest rate on the first day of SEPTEMBER 01, 2007, and the adjustable interest rate I will pay may change on that day every sixth (6) month thereafter. The date on which my initial fixed interest rate changes to an adjustable interest rate and each date thereafter on which my adjustable interest rate could change is called a "Change Date."

(B) The Index

Beginning with the first Change Date, my adjustable interest rate will be based on an Index. The "Index" is the average of interbankoffered rates for six-month U.S. dollar-denominatedleposits in the London market ("LIBOR"), as published in the Wall Street Journal. The most recent Index figure available as of the date of the first business day of the month immediately preceding the month in which a Change Date occurs is called the "Current Index."

If the Index is no longer available, the Note Holderwill choose a new index that is based on comparable information. The Note Holder will give me notice of this choice.

(C) Calculation of Changes

Before each Change Date, the Note Holder will calculate my new interest rate by adding FIVE AND NO/100 percentage points (5.00 %) to the Current Index for such Change Date. The Note Holder will then round the result of this addition to the nearest one-eighth of one percentage point (0.125%). Subject to the limits stated in Section 4(D) below, this rounded amount will be my new interest rate until the next Change Date.

During the Interest-OnlyPeriod. at each Change Date, the Note Holderwill determine the amount of the monthly payment that would be sufficient to repay accrued interest. This will be my monthly payment until the earlier of the next Change Date or the Change Date following the end of the Interest-OnlyPeriod (i.e., the Change Date prior to the 61st payment or "First Fully-Amortizing Change Date) unless I make a voluntary prepayment of principal during such period. If I make a voluntary prepayment of principal during the Interest-OnlyPeriod, my payment amount for subsequent payments will be reduced by the amount necessary to pay interest at the then current interest trate on the lower principal balance.
