SUMMARY FINAL JUDGMENT

THIS CAUSE having come before the Court upon a hearing on Plaintiff's Motion for Summary Judgment on Monday, September 19, 2005, and the Court having reviewed the pleadings and considered the arguments of counsel,

IT IS HEREBY ORDERED AND ADJUDGED:

1. Defendant, Stanley Valta, breached the promissory note dated May 18, 2005. As a result, Defendant owes Plaintiff, George Svetlik, \$58,000.00, plus prejudgment interest at the rate of 7.0% from June 15, 2005, the date of the breach, through September 19, 2005. The total amount of prejudgment interest is \$699.84. In addition thereto, Defendant must reimburse Plaintiff his costs in the amount of \$280.00, which consist of the filing and service of process fees.

2. Plaintiff, George Svetlik, shall recover from Defendant, Stanley Valta, 23029 Seneca Avenue, Port Charlotte, FL 33952, the amount of \$38,979.84 that shall bear interest at the rate of 7.0% per annum, for which let execution issue.

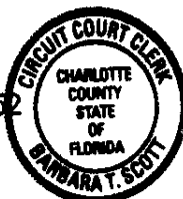
