

- At all relevant times, Claimant had a cont act with Owner and Owner's tenant, Farm CP, for the improvement of the Property for Claimant to perform interior renovation work in Suite 208, including, but not limited to, the demolition and construction of interior partitions, lights, carpet and electrical wiring, pursuant to a written contract between Claimant and Farm CP dated July 20, 2005 and a written contract between Claimant and Owner's Agent dated July 20, 2005.
- The total contract sum is the original contract sum of eighty are thousand six hundred and fifty-five and 20/100 dollars (\$85,655.20), plus change orders totaling two thousand three hundred and ten dollars (\$2,310.00), for a total contract price of eighty-seven thousand nine hundred and sixty-five and 20/100 dollars (\$87,965.20).
- Claimant substantially completed its work valued at eighty-seven thousand n ne hundred and 4. sixty-five and 20/100 dollars (\$87,965.20) under the contracts on August 5, 2005. The last date of work for Claimant at the Property was September 19, 2005.
- After giving credit for all payments received, the sum of seventy-one thousand one hundred and seventy-six dollars (\$71,176.00) is due and owing to Claimant and has not been paid, despite Claimant's demand. Claimant now claims a lien for \$71,176.00, plus interest, on the Property.
