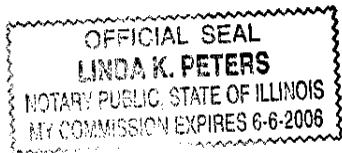

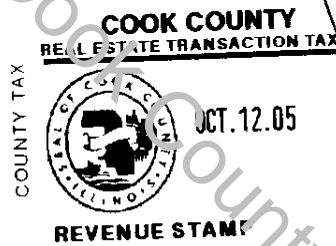

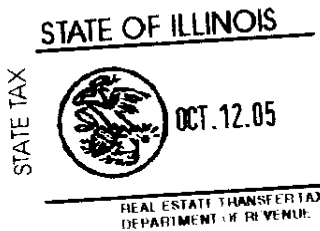
Parking Space Unit P-55 in The Lancaster Condominium as delineated on a Survey of the following described parcel of real estate:

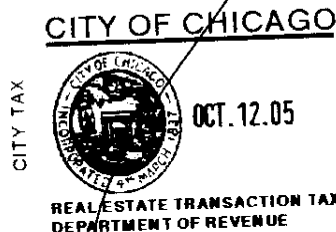
