

ORDER

This cause having come before the Court pursuant to the Motion for Summary Judgment of the Petitioner/Counter-Respondent, E.B.N. Enterprises, Inc. ("EBN") and the Motion for Summary Judgment filed by the Respondents/Counter-Petitioners, SPRO SIAVELIS ("Spiro") and DEBORAH SIAVELIS ("Deborah") (sometimes collectively "Siavelis"), the Court having reviewed the pleadings of the parties and heard oral argument of counsel, and the Court having begon advised in the premises;

THE COURT FINDS:

- (1) The procedural questions raised by Siavelis in their pleadings merged into the arbitration proceeding, the arbitrator being in the best position to make an assessment regulating EBN's compliance with such procedural issues; and
 - (2) The order of injunctive relief is punitive, repressive and a restraint of trade.
 IT IS HEREBY ORDERED:
- (1) The Arbitrator's award in the amount of \$454,537.96 assessed against Siavelis is confirmed, and judgment is entered in favor of EBN and against Siavelis in the amount of Four-Hundred Fifty Four Thousand Five-Hundred Thirty-Seven and 96/100 Dollars (\$454,537.96), which amount accrues statutory interest beginning (30) days from and after December 9, 2004, the date of the Award of Arbitrator;

Deborah, and both of them, are hereby enjoined and shall immediately cease and desist from operating any of their salons under the American Hair name or using any name other than that permitted by their franchise agreements with EBN, and they are hereby enjoined and restrained from operating any other salons such as are described in the various Franchise Agreements between the parties, at any other locations, for a term of two (2) years from and after December 9, 2004, the date of the Award of Arbitrator; and
