PARTIAL RELEASE (SATISFACTION) OF JUDGMENT & AMENDMENT TO MEMORANDUM OF JUDGEMENT

Susan Stone, individually and is Special Administrator of the Estate of John Stone, Deceased (the "Judgement Creditor") having received partial satisfaction and payment in the amount of \$1,300,000.00, does hereby partially release the judgement in the amount of \$3,049,431.00 and costs entered on March 15, 2004 against Mercy Hospital and Medical Center (the "Defendant") to the extent of \$1,300,000.00. The balance of the judgement as of the date this Partial Release is recorded is \$1,749,431.00 and such balance remains unsatisfied and unaffected by this Partial Release. The Judgement Creditor does hereby amend the Memorandum of Judgement recorded on November 19, 2004 as document number 0432427095 (the "Original Memorandum of Judgment") by adding the following limitations and qualifications (the Original Memorandum of Judgement as amended hereby, the "Memorandum of Judgment"): The Memorandum of Judgement, limited to the existing outstanding balance of the judgement and the amount of the Memorandum of Judgement shall be reduced automatically when and as payments are made pursuant to the Settlement Agreement. The obligation of the Defendant to the Judgement Creditor under the Memorandum of Judgement shall be specifically and exclusively secured by certain real property of the Defendant located at 8541 South State Street, Chicago, Illinois with P.I.N. numbers 20-34-312-004 and 20-34-312-006 (the "Premises") in accordance with the terms of that certain Mortgage recorded on September 13, 2005 as document number 0525627110, in favor of the Judgement Creditor (the "Mortgage"), the terms and conditions of which are not modified by this Partial Release. A copy of the legal description of the Premises is attached hereto as Exhibit A. No other property of the Defendant, real or otherwise, shall be subject to liens, encumbrances, claims, demands, easements, covenants, conditions and restrictions of any kind or nature whatsoever in favor of or by the Judgement Creditor as a result of the

Notwithstanding the foregoing, in the event of a default by Defendant under the Settlement Agreement, Judgment Creditor shall have the right to pursue all remedies thereunder including the right to proceed against Defendant's other properties provided Judgment Creditor reduces her claims thereunder to another judgment against Defendant for breach of the Settlement Agreement.
