THIS INDENTURE WITNESSETH, That the Grantor(s), Eileen C. Roulo of 502 Feldner Court in Palos Heights, Illinois 60463 in the County of Cook and in consideration of Ten----- (\$10.00) ----- Dollars, and other good and valuable considerations in hand, paid, Convey(s) and Warrant(s) unto the **PALOS BANK AND TRUST COMPANY**, an

Illinois Banking Corporation of the United States of America, as Trustee under the provisions of a Trust Agreement dated the 17th day of November, 2000 and known as Trust Number 1-4968 the following described real estate in the County of Cook in the State of Illinois, to wit:

Parcel 1: That part of Lot 5 in the Villas of Palos Heights, Planned Unit Development, being a Subdivision of the North 671.53 feet (except the East 900 feet thereof and except the West 165 feet of the North 283 feet thereof and except that part taken for highway) of the Northeast ¼ of the Northeast ¼ of Section 31, Township 37 North, Range 13, East of the Third Principal Meridian, described as follows:

Commencing at the Southwest corner of said Lot 5; thence due East, along the South line of said Lot 5, 22.32 feet; thence North 0 degrees 21 minutes 25 seconds East, 30.48 feet; thence South 89 degrees 38 minutes 35 seconds East, 62.70 feet to a point on the Southerly extension of the center line of a party wall; thence North 0 degrees 37 minutes 20 seconds East, along said extension, 6.16 feet to a point of beginning; thence continuing North 0 degrees 37 minutes 20 seconds East, along said extension and center line, 45.50 feet to an intersection with the center line of a party wall; thence South 89 degrees 38 minutes 35 seconds East, along said center line and the Easterly extension thereof, 72.77 feet; thence South 0 degrees 21 minutes 25 seconds West, 39.34 feet; thence North 89 degrees 38 minutes 35 seconds West 72.95 feet to the point of beginning, all in Cook County, Illinois.

Parcel 2: Easement for the benefit of Parcel 1 as created by the Declaration of Party Wall Rights, Covenants, Conditions and Restrictions and Easements for the Villas of Palos Heights recorded July 1, 1994 as Document 94578976 and First Supplementary Declaration recorded November 7, 1994 as Document 94949073 and by Deed from Chicago Title and Trust Company, as Trustee under Trust Number 1098688 to the Werderitch Family Trust dated June 3, 1993 recorded September 11, 1996 as Document 96695619, for ingress and egress, in Cook County, Illinois.

In no case shall any party, to whom said premises, or any part thereof, shall be conveyed, contracted to be sold, leased or mortgaged by said Trustee, and in no case shall any party dealing with said Trustee in relation to said premises, be obliged to see to the application of any purchase money, rent or money borrowed or advanced on said premises or be obliged to see that the terms of this Trust have been complied with, or be obliged to inquire into the necessity or expediency of any act of said Trustee, or be obliged to inquire into the necessity or expediency of any act of said Trustee, or be privileged or obliged to inquire into any of the terms of said Agreement.

The interest of each and every Beneficiary (ies) hereunder and of all persons claiming under them, is hereby declared to be personal property and to be in earning avails and proceeds arising from the disposition of the premises; the intention hereof being to vest in the said **PALOS BANK AND TRUST COMPANY** the entire legal and equitable title in fee, in and to all of the premises above described.

All persons and corporations whomsoever and whatsoever shall be charged with notice of this condition from the date of the filing for record of this Deed.

Any the said Grantor(s) hereby expressly waive(s) and release(s) any and all right or benefit under and by virtue of any and all statutes of the State of Illinois providing for the exemption of homesteads from sale on execution or otherwise.

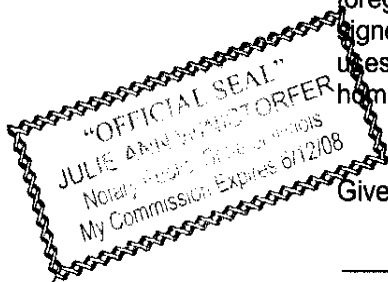

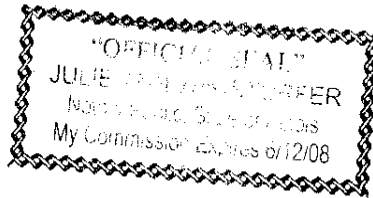

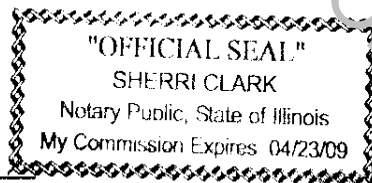
