Payment of Principal, Interest, Escrow Items, Prepayment Charges, and Late Charges. Borrower subject to Lender's right to disapprove Borrower's choice, which right shall not be exercised unreasonably. These amounts shall bear interest at the Note rate from the date of disbursement and shall be payable, with such interest, upon notice from Lender to Borrower requesting payment.


