On April 8, 2005, an Order for the Demolition of the structure located on said property was entered by the Sixth Municipal District Circuit Court of Cook County pursuant to the Illinois Municipal Code, 65 ILCS 5/11-31-1(a). On November 9, 2005 an Order was entered in the Sixth Municipal District Circuit Court of Cook County establishing a lien in the amount of \$14,449.77, an amount which represents the fair and reasonable cost to demolish said structure located on said premises, including court costs, attorney's fees and any other costs relating to the demolition and the enforcement of this provision of the Illinois Compiled Statutes. This lien is a priority lien on the real estate described herein above, and which lien, pursuant to statute, is superior to all prior existing liens and encumbrances on the real estate. The City of Calumet City reserves the right to amend the amount of this lien to reflect any additional costs incurred by the City of Calumet City in relation to the demolition of the above referenced property.
