THIS AMENDMENT TO THE DECLARATION OF CONDOMINIUM OWNERSHIP AND OF EASEMENTS, RESTRICTIONS AND COVENANTS FOR LARAMIE SQUARE CONDOMINIUM is made by the Board of Managers and Unit Owners at a meeting called for that purpose this 4th day of November 2005.

WITNESSETH:

Amendment to Declaration of Condominium Ownership and of Easements, Restrictions and Covenants for Laramie Square Condominium Association.

We, the undersigned, duly qualified Unit Owners of the Laramie Square Condominium Association, in accordance with the provision of Paragraph 6, Article XI of a certain Declaration of Condominium Ownership and of Easements, Restrictions and Covenants for Laramie Square Condominium Association, dated December 27, 1973, as time to time amended, affecting the real estate described on Rider A attached hereto, hereby agree and vote to amend Paragraph 5(a), Article V of the aforesaid Declaration by substituting revised Paragraph 5(a), Article V as follows:

ARTICLE V
ADMINISTRATION

5. Board of Managers.

(a) At the initial meeting, the Owners shall elect a Board of Managers, to serve until the next Annual Meeting of the Owners. Thereafter, at each Annual Meeting, the Owners shall elect Board members for the forthcoming year. The Owners shall, in such

elections, vote on a cumulative voting basis and the candidates receiving the highest number of votes with respect to the number of persons to be elected to the Board of Managers shall be deemed elected.
