MODIFICATION OF MORTGAGE

THIS MODIFICATION OF MORTGAGE dated 11-17-2005 is made and executed between Arthur F. Richards, whose address is 250 East Pearson #1202, Chicago, IL 60611 (referred to below as "Grantor") and Heritage Community Bank, whose address is 18301 South Halsted Street, Glenwood, IL 60425 (referred to below as "Lender").

This waiver applies not only to any initial extension or modification, but also to all such subsequent actions.

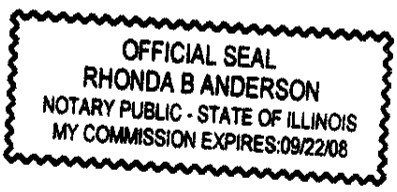

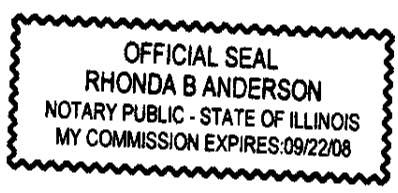
