#### WITNESSETH

WHEREAS, the Authority, Jazz and the Partnership have previously executed and recorded the Declaration, which encumbers certain property described in Exhibits A and B thereto with certain affordability requirements, and imposes certain other obligations upon the Partnership; and

WHEREAS, Jazz has converted to a condominium form of ownership or is simultaneously with the recording of this Amendment converting to a condominium form of ownership, the Rental Units and For Sale Units identified as such on Exhibits 1 and 2 to this Amendment ("Converted Rental Units" and "Converted For Sale Units, respectively), together with their undivided interest in all common elements and limited common elements and appurtenants rights and is conveying such Converted Rental Units to the Partnership; and

WHEREAS, the Authority desires to amend Exhibit B to the Declaration so as to encumber the Converted Rental Units, and to amend and restate such Exhibit in its entirety;

NOW THEREFORE, in consideration of the mutual promises and covenants hereinafter set forth, and of other valuable consideration, Jazz, the Partnership and the Authority each agree as follows:
