Such loss reserve shall be non-refundable, notwithstanding the fact that the Loan is ultimately paid in full, and Lender shall not be required to pay Borrower any interest or earnings on such loss reserve. an institution whose deposits are insured by a federal agency, instrumentality or entity; or (d) Electronic Funds Transfer.
