ILLINOIS STATUTORY SHORT FORM POWER OF ATTORNEY FOR PROPERTY for CHERYL L. CAMPBELL

The powers granted above shall not include the following powers or shall be modified or limited in the following particulars (here you may include any specific limitations you deem appropriate, such as a prohibition or conditions on the sale of particular stock or real estate or special rules on barrowing by the agent):
