Section 1.3 SECURITY AGREEMENT: FIXTURE FILING. (a) This Security Instrument is both a real property mortgage and a "security agreement" within the meaning of the Uniform Commercial Code as adopted and enacted by the State or Commonwealth where the Property is located (as amended, modified or replaced from time to time, the "UCC"). This Security Instrument and the grants, assignments and transfers made herein are also given for the purpose of securing the performance of all other obligations of Borrower contained herein and the performance of each obligation of Borrower contained in the other Loan Documents (all of such obligations, together with Borrower's obligations for the payment of the Debt. collectively, the "<u>Obligations</u>").

#### **Article 3** - BORROWER COVENANTS

Borrower covenants and agrees that:

Section 3.1 PAYMENT OF DEBT. Borrower will pay the Debt at the time and in the manner provides in the Note and the other Loan Documents.

Section 3.2 INCORPORATION BY REFERENCE.   - (2) Commercial general liability insurance under a policy containing "Comprehensive General Liability Form" of coverage (or a comparably worded form of coverage) and the "Broad Form CGL" endorsement (or a policy which otherwise incorporates the language of such endorsement), providing coverage on an occurrence (not "claims made") basis, which policy shall include, without limitation, coverage against claims for personal injury, bodily injury, death and property damage liability with respect to the Property and the operations related thereto, and the following coverages: Employee as Additional Insured, Product Liability/Completed Operations, Independent Contractor, Personal Injury and Advertising Injury Protection, hired and non-owned automobile coverage (including rented and leased vehicles),
