THIS SUBORDLY TION ("Subordination") is made as of this _____ day of October, 2005 by the CITY OF CHICAGO, an Illinois municipal corporation, having its principal office at City Hall, Chicago, Illinois 60502 ("City").

RECITALS

WHEREAS, the City Council of the City, by ordinance adopted June 7, 1990, established the New Homes for Chicago Program ("New Homes Program") to facilitate the construction of new single family housing or two-flat building within the City which shall be affordable to many families; and

WHEREAS, <u>Elaine V. Thomas</u> ("Mongagor") purchased from <u>Investment Management Corporation</u>, an <u>Illinois not for profit corporation</u> ("Developer), a single family housing unit or two-flat housing, as the case may be ("Unit"), improving that certain property redeveloped by Developer pursuant to the objectives of the New Homes Program and a Redevelopment Agreement executed by Developer and the City, which Unit is commonly known as <u>7715 North Hermitage</u>, <u>Unit 1J</u>, Chicago, Illinois ("Property") and legally described on <u>Exhibit A</u> attached hereto; and

WHEREAS, at closing, and as a pre-condition to the purchase of the Property by Mortgagor, the Mortgagor executed those certain Mortgage, Security and Recapture Agreements in favor of the City both dated as of <u>December 6, 2002</u> and recorded with the Office of Recorder of <u>December 6 Cook County</u>, Illinois on <u>December 13, 2002</u> as Document Nos. <u>021376979</u> and <u>021376980</u> ("City Mc tga ges").

WHEREAS, the Mortgagor seeks to refinance the existing first mortgage on the Property; and

WHEREAS, in order to facilitate the refinancing, the City shall subordinate to the pertinent City Mortgages, as described herein;
