This First Amendment to Mortgage ("First Amendment") is dated as of this 6th day of December, 2005, and is made between Kevin S. Fox, whose address is 7502 Pandolph Street, Forest Park, Illinois 60130 ("Mortgagor") and TCF National Bank, a national banking associat on ('Mortgagee"), with an office located at 800 Burr Ridge Parkway, Burr Ridge, Illinois 60527.

<u>UNDERSTANDINGS</u>

- The Mortgagor executed a Mortgage in favor of the Mortgagee dated as of August 31, 2000 and recorded October 4, 2000 as document number 00778140 in the office of the County Recorder in and for Cook County, Illinois ("Mortgage") encumbering the real estate described on Exhibit A, artuched hereto and made a part hereof.
- The Mortgage secures the indebtedness, obligations and liabilities of Mortgagor pursuant to a promissory note in the original principal amount of Two Hundred Ninety-two Thousand and 00/100 Dollars (\$292,000.00), payable to Mortgagee and executed jointly and severally by Mortgagor ("Note").
- The principal balance of the Note is due and payable on September 10, 2015. As of the date hereof, the outstanding principal balance due is \$254,928.90.
- Mortgagor wishes to amend the terms of the Note and the Mortgage, and Mortgagee is willing to do so. 4.

NOW, THEREFORE, in consideration of the Understandings as set forth above and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Mortgagor and the Mortgagee agree as follows:

That the Mortgagor has requested an advance of additional principal to increase the face amount of the Note to Four Hundred Twenty-Five Thousand and 00/100 Dollars (\$425,000.00). Concurrent with the execution and delivery hereof, the Mortgagee will advance the amount of One Hundred Seventy Thousand Seventy-One and 10/100 Dollars (\$170,071.10) ("Additional Advance") in favor of the Mortgagor, which amount represents the difference between the current outstanding principal balance of the Note and the new principal amount of \$425,000.00.
