AMENDMENT NO. 5 TO ASSIGNMENT OF LEASES AND RENTS -LASALLE BANK NATIONAL ASSOCIATION TRUST NO. 25-7659

Amendment No. 5 to Assignment of Leases and Reats dated as of November 1, 2005, made by LASALLE BANK NATIONAL ASSOCIATION, not individually, out colely as successor trustee to AMERICAN NATIONAL BANK & TRUST COMPANY OF CHICAGO, as successor trustee to First Chicago Bank of Ravenswood under that certain Trust Agreement dated March 17, 1926 and known as Trust No. 25-7659 ("Assignor") in favor of LASALLE BANK NATIONAL ASSOCIATION F/K/A LASALLE NATIONAL BANK F/K/A LASALLE BANK NI ("Assignee"). This Amendment partains to the real estate described on Exhibit A attached hereto and made a part hereof.

PREAMBLE:

Assignor gave to Assignee that certain Assignment of Leases and Rents dated May 30, 1996, as amended as of July 10, 1997, as of February 6, 1998, and as of July 28, 1998 which were recorded on Jun; 5, 1996, July 16, 1997, February 27, 1998 and August 5, 1998, respectively, in the Office of the Cook County, Illinoic Recorder of Deeds as Document Nos. 96426500, 97512726, 98158527 and 98686883, respectively (collectively, the "Assignment"). Assignor and the beneficiary of Assignor ("Beneficiary") have requested Assignee to modify Assignee's existing financing of Beneficiary. Assignee has agreed to do so, so long as, among other things, Assignor executes and delivers to Assignee this Amendment.

NOW, THEREFORE, in consideration of the premises which are incorporated herein by this reference and constitute an integral part hereof and the execution and delivery of this Amendment, Assignor agrees as follows:

1. Section 1.01 of the Mortgage is amended to as follows:

"1.01 Notes. Pursuant to that certain Loan and Security Agreement dated the date of this Assignment, as amended from time to time, entered into by and among Assignee, Saf-T-Gard International, Inc. ("Borrower 1") and the

beneficiary of Assignor (said beneficiary shall be referred to as the "Beneficiary") (said Loan and Security Agreement, as amended and as may be further amended or restated from time to time, shall be hereinafter referred to as the "Loan Agreement"), (A) that certain Revolving Note (said Revolving Note, as may from time to time be amended, modified, substituted, restated, renewed and/or extended, shall hereinafter be referred to as the "Revolving Note") in the principal amount of \$3,000,000.00 payable, along with interest, and maturing as specified in the Revolving Note has been or is being contemporaneously executed and delivered by Borrower 1 to Assignee; (B) that certain Term Note (said Term Note, as may from time to time be amended, modified, substituted, restated, renewed and/or extended, shall hereinafter be referred to as the "Term Note") in the principal amount of \$1,800,000.00 payable, along with interest, and maturing as specified in the Term Note; and (C) that certain Revolving Note 2 (said Revolving Note 2, as may from time to time be amended, modified, substituted, restated, renewed or extended, shall hereinafter be referred to as the "Kew Juing Note 2") (the Revolving Note, the Term Note and the Revolving Note 2 so ll hereinafter be individually referred to as a "Note" and collectively as the "Notes") in the principal amount of \$750,000.00 payable, along with interest, and maturing as specified in the Revolving Note 2 have been or are being contemporar eously executed and delivered by Assignor, Borrower 1 and/or Beneficiary to Assignee. The Revolving Note and the Revolving Note 2 contemplate a variable rate of interest."

2. The second paragraph of Section 1 03 of the Assignment is amended to read as follows:

"This Assignment is given in part to sec ure the "Line of Credit" obligations as evidenced and witnessed by the Revolving Now and the Revolving Note 2, and secures not only the indebtedness from Assignor, Borrower 1 and/or Beneficiary existing on the date hereof, but all such future advances, whether such surances are obligatory or to be made at the option of the Assignee, or otherwise as are made within 20 years from the date hereof, to the same extent as if such future advances were made on the date of the execution of this Assignment, and although there may be no indebtednes; outstanding at the time any advance is made. The lien of this Assignment as to third persons without actual notice thereof shall be valid as to all indebtedness and future covances from the time this Assignment is filed for record in the Office of the Recorder of Deeds of the County set forth on Exhibit A attached hereto. The total amount of revolvir g indebtedness that may be secured by this Assignment may increase or decrease from time time, but the total unpaid balances of the Revolving Note and the Revolving Note 2 secure 1 at my one time, shall not exceed the maximum principal amount of the aggregate of the Per Siving Note and the Revolving Note 2 (each as amended, extended, substituted, restated, replaced or renewed from time to time), plus interest thereon and any disbursements made by the Assignee for the payment of taxes, special assessments, or insurance on the above described real estate, with interest on such disbursements."

- 3. All references to the "Assignment" in the Assignment shall mean the "Assignment" as amended by this Amendment and as may be further amended and/or restated from time to time.
- 4. In all other respects, the Assignment is hereby restated, reaffirmed and incorporated herein, the only amendments intended to be made thereto being those above set forth. Except as specifically set forth herein to the contrary, all terms defined in the Assignment shall have the same meanings herein as therein.
- 5. This Amendment is executed by Mortgagor, not personally but as trustee as aforesaid, in the exercise of the power and authority conferred and fixed in its as such trustee, and it is expressly understood and agreed that nothing herein contained shall be constituted as creating any liability on Mortgagor as trustee as aforesaid, or on Mortgagor personally, to pay the Obligations or any interest that may accrue thereon, or any indebtedness accruing

hereunder, or to perform any covenant either express or implied herein contained, all such liability on Mortgagor, if any, being expressly waived by Mortgagee and by every person now or hereafter claiming any right or security hereunder. Each and all of the representations, warranties, covenants, undertakings and agreements made by the Mortgagor as trustee as aforesaid are made for the purpose of binding (and shall be enforceable against) the Beneficiary and its, his, her and/or their successors and assigns. So far as Mortgagor as trustee as aforesaid, and its successors, and the Mortgagor, personally, are concerned, Mortgagee and the holder or holders of the Notes and the owner or owners of the indebtedness accruing hereunder shall look solely to the property hereby conveyed for the payment thereof, by the enforcement of the lien hereby created, in the manner herein and in the Notes provided, or by action to enforce the personal liability of any Guarantor or co-maker.
