### **MEMORANDUM OF LEASE**

This Memorandum of Lease ("Memorandum") is made as of November 30, 2905, by and between Dearborn Construction & Development, Ltd., an Illinois corporation ("Lessor"), as lessor, and White Hen Pantry, Inc., a Delaware corporation ("Lessee"), as lessee.

Lessor hereby leases to Lessee and it essee hereby lets from Lessor, upon the terms and conditions fully described in that certain unrecorded lease dated November \_\_\_\_, 2005 by and between Lessor and Lessee (the "Lease"), certain premises to cated in the Village of Elk Grove, County of Cook, State of Illinois, as more particularly described in <u>Exhibit A</u> attached hereto (the "Premises").

TO HAVE AND TO HOLD all and singular, the Tremises for an initial term of ten (10) years commencing on March 1, 2006, subject to Lessee's option to renew the Lease for up to three (3) additional periods of five (5) years each.

The lease grants Lessee the exclusive right to sell certain products from the shopping center within which the Premises are located. The lease also restricts certain types of businesses and operations from being conducted within such shopping center. All of such exclusives and restrictions are more fully set forth in the Lease.

The purpose of this Memorandum is to give record notice of the Lease and of arc rights created thereby, all of which are hereby confirmed. This Memorandum does not and shall not modify the terms and conditions of the Lease. In the event of any inconsistency or conflict between the provisions of this Memorandum and the provisions of the Lease, the provisions of the Lease shall govern.
