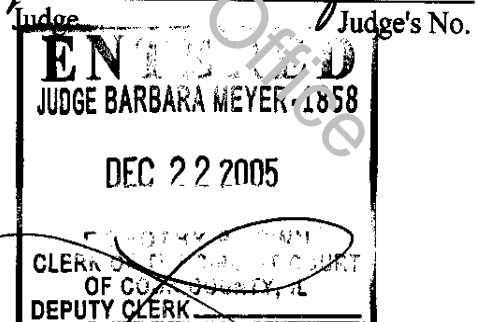
MEMORANDUM OF JUDGMENT

AGREED ORDER

1. GAIL DOUVIRIS further acknowledges that said charges are fair and reasonable.
3. Judgment is entered against GAIL DOUVIRIS and in favor of KURT A. MULLER of THE MULLER FIRM, LTD. in the amount of \$5,680.55.
4. GAIL DOUVIRIS shall satisfy said Judgment, in full, upon the entry of Judgment for Legal Separation.
5. GAIL DOUVIRIS and THE MULLER FIRM, LTD. waive their right, if any they have, to contribution towards this Judgment against ANDREW P. DOUVIRS, JR.
