RECITALS

WHEREAS, Victor Castillo and Priscilla Escobar (collectively "Mortgagor") purchased from Austin Lighthouse, L.L.C., an Illinois limited liability company, a single family housing unit or two-flat building, as the case may be ("Unit") improving that certain property redeveloped pursuant to the Redevelopment Agreement, New Homes For Chicago Program, A istin Lighthouse, L.L.C., entered into pursuant to the objectives of the New Homes for Chicago Program which Unit is commonly known as 1013 North Keeler Avenue, Chicago, Illinois 60651 ("Property") and legally described on Exhibit A attached hereto; and
