PARTIAL RELEASE OF DECLARATION OF TRUST

KNOW ALL MEN BY THESE PRESENTS, that the United States of America, Secretary of Housing and Unban Development, by its duly authorized Director of the Office of Public Housing, in consideration of One Dollar (\$1.00) and other good and valuable consideration, received to its full satisfaction from the Chicago Housing Authority, a municipal corporation, does hereby release from the operation and effect of that certain Declaration of Trust, dated as of March 24, 1960, and recorded April 5, 1960 in the Office of the Recorder of Deeds, Cook County, Illinois as Documer (No. 17822029, made by the Chicago Housing Authority in connection with Project No. Illinois 2-21 (the "Declaration"), the following portion of the property described in the Declaration:

LOTS 1, 3, 5, 7, 10, 12, 13, 14, 15, 17, 18, 19, 23, 24, 25, 29, 33, 34 AND 37, THE EAST 0.98 FEET OF LOT 26, AND THE EAST 0.98 FEET OF LOT 41 IN THE EEE RESUBDIVISION, BEING A RESUBDIVISION AND CONSOLIDATION OF PARTS OF CHAPMAN BROS. SUBDIVISION, B.W.THOMAS'S SUBDIVISION, G.M.
