SHARI DENISE DuBROW, under the penalties of perjury, states:

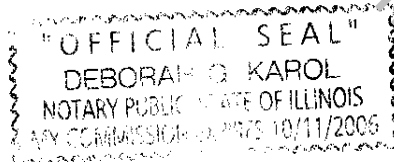
1. The Decedent, MARY DuBROW, died a resident of Glenview, Illinois, on September 29, 2005.
