D. A. HEENAN, the duly appointed, qualified and acting Trustees under the Will and of the Estate of James Campbell, Deceased, and certified for appeal in the manner provided by Rule 54(b), Hawaii Rules of Civil Procedure, as follows:

1. RICHARD W. GUSHMAN, II, is appointed a trustee under the Will and of the Estate of James Campbell, Deceased, for a term commencing on May 1, 2000, and expiring upon the earlier of the death or legal incapacity of RICHARD W. GUSHMAN, II, or this Court's approval of the Trustees' final accounts and distribution of the assets of the trust subsequent to its termination, beyond which he shall have no further authority to act as a trustee of the Estate. This appointment is subject to the filing of a bond as provided in Paragraph 5 below.

2. Upon the filing of the bond specified in Paragraph 5 below, as of May 1, 2000, legal title in and to all of the trust property, assets and choses in action forming the estate heretofore vested in C. R. Churchill and D. A. Heenan, Trustees under the Will and of the Estate of James Campbell, Deceased, is vested in C. R. CHURCHILL, D. A. HEENAN and RICHARD W. GUSHMAN, II, jointly as Trustees under the Will and of the Estate of James Campbell, Deceased, and that, pursuant to the Will on file herein and the provisions of §554A-6(a) of the Hawaii Revised Statutes, the action of a majority of the Trustees shall be binding upon said Estate.

3. RONALD J. ZLATOPER is appointed a trustee under the Will and of the Estate of James Campbell, Deceased, for a term commencing on July 1, 2000, and expiring upon the earlier of the death or legal incapacity of RONALD J. ZLATOPER, or this Court's approval of the Trustees' final accounts and distribution of the assets of the trust subsequent to its termination, beyond which he shall have no further authority to act as a trustee of the Estate. This appointment is subject to the filing of a bond as provided in Paragraph 5 below.

4. Upon the filing of the bond specified in Paragraph 5 below, as of July 1, 2000, legal title in and to all of the trust property, assets and choses in action forming the estate heretofore vested in C. R. CHURCHILL, D. A. HEENAN and RICHARD W. GUSHMAN, II, Trustees under the Will and of the Estate of James Campbell, Deceased, is

ZLATOPER, jointly as Trustees under the Will and of the Estate of James Campbell, Deceased, and that, pursuant to the Will on file herein and the provisions of §554A-6(a) of the Hawaii Revised Statutes, the action of a majority of the Trustees shall be binding upon said Estate.

5. The above provisions of this order are subject to the filing with the Clerk of this Court of bonds in the sum of Two Hundred Thousand Dollars (\$200,000), one with RICHARD W. GUSHMAN, II, as principal and one with RONALD J. ZLATOPER as principal and in such form and with such surety or sureties as shall be approved by this Court.

6. A fee of \$1,200 is allowed to the Guardian ad Litem as a reasonable fee for his services herein.
