All parties who are interested in bidding at the sale <u>must</u> obtain a bid package. The bid package contains sample copies of accuments that the purchaser must deliver at the sale and copies of documents that the purchaser must execute at closing. The bid package also describes, among other things, the procedure for prorating real estate taxes, and the purchaser's obligations after the sale. In addition, the bid package describes the specific repairs that the purchaser must perform.

When making their bid, all bidders except the Secretary must submit a deposit totaling \$100,000.00 in the form of a certified check or cashier's check made out to the Secretary of HUD. Each oral bid must be accompanied by a deposit. If the successful bid is oral, a deposit of \$100,000.00 must be presented before the bidding is closed. The deposit is nonrefundable.
