### Article One: My Family

As of the clate of this will, I am married to RISHA ROSENBURG and I have two children now living, pamely: HOWARD JORDAN ROSENBURG and MICHAEL DAVID ROSENBURG.

## Article Two: Property

I give all my personal and real property not previously disposed of, both tangible and intangible, and any policies of insurance of that property, to my wife, RISHA ROSENBURG.

### Article Three: kesidue of Estate

All the residue of my estate, wherever situated, I give to my wife, RISHA ROSENBURG.

### Article Four: Executor

- 1. Appointment. I appoint my son, HOWARD JORDAN ROSENBURG, as executor of this will. If for any reason HOWARD JORDAN ROSENBURG is unwilling or unable to act as executor, I appoint my son, MICHAEL DAVID ROSENBURG, as executor of this will. If for any reason MICHAEL DAVID ROSENBURG is unwilling or unable to act as executor, I appoint THOMAS DALLAS, of Lincolnwood, Illinois as my executor.
- 2. (a) <u>Debts, taxes, administration expenses</u>. My executor shall pay from the residue of my estate all proper charges against my estate.
- (b) Assets to be sold. My executor's selection of assets to be sold to make the foregoing payments or to satisfy pecuniary legacies, and the tax effects thereof, shall not be subject to question or any beneficiary.
- (c) Tax elections. Except as otherwise specifically provided, my executor shall make such elections and allocations under the tax laws as my executor deems advisable.
- 3. Executor's powers. I give my executor power to invest in bonds, stocks, notes or other property, lease, borrow with or without security from any lender including an executor hereunder individually or a parent of exercise company, sell or exchange all or any part of my estate, real or personal, for such prices and upon such terms as my executor deems proper; to exercise options to purchase stock of any corporation and to borrow money and pledge assets of my estate for that purpose; to compromise, contest, prosecute or abandon claims in favor of or against my estate; to distribute income and principal in cash or in kind, or partly in each, and to allocate or distribute undivided interests or different assets or disproportionate interests in assets (and no adjustment shall be made to compensate for a disproportionate allocation of unrealized gain for Federal income tax purposes), and to value my estate in order to make allocation or distribution, and no action taken by my executor pursuant to this power shall be subject to question by any beneficiary; and to execute and deliver necessary instruments and give full receipts and discharges. The foregoing powers shall be exercised by my executor without authorization by any court and, as to property subject to administration outside the state of my domicile, only with the approval of my domiciliary executor.
  - 4. <u>Waiver of bond</u>. No bond or security shall be required of any executor wherever acting. If permitted by law and if not inconsistent with the best interests of the teneficiaries as determined by my executor, the administration of my estate shall be independent of the supervision of any court.
  - 5. <u>Headings</u>. Headings used in this will are for ease of reference only and shall not be used to construe any provision.
