#### **CONDOMINIUM RIDER**

THIS CONDOMINIUM RIDER is made this 16th day of December, 2005, and is incorporated into and shall be deemed to amend and supplement the Mortgage, Deed of Trust or Security Deed (the "Security Instrument") of the same date given by the undersigned (the "Borrower") to secure Note to TCF National Bank,

"Lender") of the same date and covering the Property described in the Security Instrument and located at: 1877 N. WINNEBAGO #1W CHICAGO IL 60622

The Property includes a unit in, together with an undivided interest in the common elements of, a condominium project known as: WINNEBAGO AVENUE CONDOMINIUM

(the "Condominium Project"). If the owners association or other entity which acts for the Condominium Project (the "Owners Association") holds title to property for the benefit or use of its members or shareholders, the Property also includes Borrower's interest in the Owners Association and the uses, proceeds and benefits of Borrower's interest.

In addition to the covenants and agreements made in the Security Instrument, Borrower and Lender further covenant and agree as follows:

- \*\*. Condominium Obligations. Borrower shall perform all of Borrower's obligations under the Condominium Project. Constituent Documents. What Lender requires as a condition of this waiver can change during the term of this loan.

Borrower shall give Lender romp, notice of any lapse in required property insurance coverage provided by the master or blanket policy.

In the event of a distribution of planety, insurance proceeds in lieu of restoration or repair following a loss to the Property, whether to the unit or to common elements, any proceeds payable to Borrower are hereby assigned and shall be paid to Lender for application to the sums secured by the Security Instrument, with any excess, if any, paid to Borrower.

- C. Public Liability Insurance. Borrower shall take such actions as may be reasonable to insure that the Owners Association maintains a public liability insurance polic acceptable in form, amount, and extent of coverage to Lender.

  - (ii) any amendment to any provision of the Constituent Documen's if the provision is for the express benefit of Lender;
  - (iii) termination of professional management and assumption of se'.-m².nagement of the Owners Association; or
  - (iv) any action which would have the effect of rendering the public liability in surance coverage maintained by the Owners Association unacceptable to Lender.
- **E. Remedles.** If Borrower does not pay condominium dues and assessments when due, then Lender may pay them. Any amounts disbursed by Lender under this paragraph E shall become additional decorption of Borrower secured by the Security Instrument.
