SECOND MORTGAGE

THIS SECOND MORTGAGE (the "Mortgage") is dated as of September 15, 2005, by and between PRAIRIE BANK AND TRUST COMPANY, not personally, but as Trustee under Trust Agreement dated November 18, 2003, and known as Trust No. 03-148 ("Mortgagor"), and PRAIRIE BANK AND TRUST COMPANY, an Illinois banking corporation, whose address is 7661 South Harlem Avenue, Bridgeview, Islinois 60455 (herein referred to as the "Mortgagee").

WITNESSETH

THAT WHEREAS, the beneficiary of Mortgagor has executed a Hypothecation Agreement dated September 15, 2005, pledging the Premises (as defined herein) as security for a mortgage loan (the "Loan") from Mortgagoe to Mortgagor and the beneficiary of Mortgagor (Mortgagor and the beneficiary of Mortgagor are hereinafter jointly referred to at "Borrower") in the amount of SEVEN HUNDRED THOUSAND AND NO/100 DOLLARS (\$700,000 00), as evidenced by the Promissory Note dated September 15, 2005, payable by Borrower to Mortgagee in the principal amount of SEVEN HUNDRED THOUSAND AND NO/100 DOLLARS (\$700,000,00) (the "Note"). The Loan is payable with interest at a rate equal to One Percent (1%) in excells of the Prairie Bank Base Rate per annum ("Interest Rate"), and the entire remaining balance of principal and interest is due and payable on or before May 23, 2006 (the "Maturity Date").

As used herein, the term "Prairie Bank Base Rate" at any time shall mean the rate of interest then most recently announced at Mortgagee's corporate office as the Prairie Bank Base Rate; provided, however, that if Mortgagee ceases to use the term "Prairie Bank Base Rate" in setting a base rate of interest for commercial loans, then the Interest Rate shall be determined by reference to such reasonably comparable base rate as designated in writing by Mortgagee to Mortgagor. Mortgagee makes no representation or warranty that the Prairie Bank Base Rate is the lowest or best rate of interest offered by Mortgagee to commercial or other borrowers.

NOW THEREFORE, Borrower, to secure the payment of the Indebtedness (hereafter defined) including interest and late charges in accordance with the terms, provisions and limitations of this Mortgage and of the Note, and the performance of the covenants and agreements herein contained by Mortgagor to be performed, and also in consideration of the sum of One Dollar (\$1.00) in hand paid, the receipt whereof is hereby acknowledged, does by these presents mortgage, grant, remise, release, alien and convey unto Mortgagee, its successors and assigns, all interest in real estate



located in the County of Cook and State of Illinois as more fully described in <u>Exhibit A</u> attached hereto and made a part hereof which, with the property hereinafter described, is collectively referred to herein as the "**Premises**."

The Note evidences any and all indebtedness from time to time outstanding for advances made by Mortgagee to or for the use and benefit of Borrower. Future advances shall be made by Mortgagee in accordance with requests for advances from time to time made and submitted by Borrower, provided that (i) no Event of Default has occurred or exists under the terms of the Note, and (ii) the aggregate principal amount of such future advances shall not exceed the principal amount of the Note.

This Mortgage shall also secure any and all renewals or extensions of the whole or any part of the Indebtedness hereby secured however evidenced, with interest at such lawful rate as may be agreed upon, and any such renewals or extensions or any change in the terms or rate of interest shall not impair in any manner the validity or priority of this Mortgage, nor release Borrower from personal liability for the Indebtedness (hereafter defined) hereby secured.

TOGETHER with all proprovements, tenements, reversions, remainders, easements, fixtures and appurtenances now or hereafter thereto belonging, and all rents, issues and profits thereof for so long and during all such times as Mortgagor may be entitled thereto (which are pledged primarily and on a parity with said real estate and not secondarily); all tenant security deposits, utility deposits, common area maintenance charges, real estate tax and insurance premium deposits and insurance premium rebates to which Mortgagor may be er atted or which Mortgagor may now or hereafter have therein or thereon, including (without restricting the foregoing): all fixtures, apparatus, equipment and articles (other than tenant trade fixtures which raise to the use, occupancy and enjoyment of the Premises) used to supply heat, gas, air conditioning, water light, power, sprinkler protection, waste removal, refrigeration and ventilation (whether single units or centrally controlled), it being understood that the enumeration of any specific articles of property shall in no way exclude or be held to exclude any items of property not specifically mentioned. All of the land, estate and property hereinabove described, real, personal and mixed, whether affixed or annexed or not (except where otherwise hereinabove specified) and all rights hereby conveyed and mongaged are intended so to be as a unit and are hereby understood, agreed and declared (to the maximur i extent permitted by law) to form part and parcel of the real estate and to be appropriated to the use of the real estate, and shall be, for the purposes of this Mortgage, deemed to be real estate and conveyed and nor gaged hereby.

TO HAVE AND TO HOLD the Premises unto Mortgagee and its successors and assigns until all Indebtedness evidenced by the Note is fully discharged, for the purposes and uses herein set forth.

IT IS FURTHER UNDERSTOOD AND AGREED THAT:

1. Maintenance, Repair and Restoration of Improvements, Payment of Prior Liens, etc. Mortgagor shall: (a) promptly repair, restore or rebuild any buildings or improvements now or hereafter on the Premises which may become damaged or be destroyed to substantially the same character as prior to such damage or destruction, so long as insurance proceeds are sufficient therefor; (b) keep the Premises constantly in good condition and repair, without waste; (c) keep the Premises free from mechanics' liens or other liens or claims for lien not expressly subordinated to the lien hereof (collectively called "Liens"), subject, however, to the rights of Mortgagor set forth in

Paragraph 2 below; (d) immediately pay when due any indebtedness which may be secured by a lien or charge on the Premises on a parity with or superior to the lien hereof, and upon request exhibit satisfactory evidence of the discharge of such lien to Mortgagee, subject, however, to the rights of Mortgagor set forth in Paragraph 2 below; (e) complete within a reasonable time any building(s) or other improvement(s) now or at any time in process of erection upon the Premises; (f) comply with all federal, state and local requirements of law, regulations, ordinances, orders and judgments and all covenants, easements and restrictions of record with respect to the Premises and the use thereof; (g) except as provided in the leases of the Premises, which leases are listed on the Schedule of Leases attached hereto as Exhibit B, make no alterations in the Premises without Mortgagee's prior written consent which consent shall not be unreasonably withheld or delayed; (h) suffer or permit no change in the general nature of the occupancy of the Premises without Mortgagee's prior written consent; (j) observe and comply with all conditions and requirements (if any) necessary to preserve and extend all rights, easements, licenses, permits (including without limitation, zoning variations and any nonconforming uses ar intructures), privileges, franchises and concessions applicable to the Premises or contracted for in connection with any present or future use of the Premises; and (k) pay each item of Indebtedness (hereafter defined) secured by this Mortgage when due according to the terms hereof and of the Note.

Right to Contest. Not withstanding anything in Paragraphs 4 and 5 of this Mortgage 2. to the contrary, Mortgagor may, in good faith and with reasonable diligence, contest the validity or amount of any lien on the Premises, and or fer payment and discharge thereof during the pending of such contest, provided, (a) that such contest shall have the effect of preventing the sale or forfeiture of the Premises or any part thereof, or any interest 'herein, to satisfy such lien; (b) that, within thirty (30) days after Mortgagor has been notified of the assertion of such lien Mortgagor shall have notified Mortgagee in writing of Mortgagor's intention to contest such lien; and (c) that Mortgagor shall have deposited with Mortgagee at such place as Mortgagee may from time to time in writing appoint, and in the absence of such appointment, then at the office of Mortgagee, a sum of money which shall be sufficient in the reasonable judgment of Mangagee to pay in full such lien and all interest which might become due thereon, and shall keep on diposit an amount so sufficient at all times, increasing such amount to cover additional interest whenever in the reasonable judgment of Mortgagee, such increase is advisable or shall obtain a title endorsement or title indemnity to the lender's title insurance policies of Mortgagee or a surety bond of a strety company reasonably satisfactory to Mortgagee, insuring or bonding Mortgagee against any hum as a result of such contest. Such deposits shall earn interest at no more than commercial money narket rates. If Mortgagor shall fail to prosecute such contest with reasonable diligence or shall fail to pay the amount of the lien plus any interest finally determined to be due upon the conclusion of such contest, to the extent such amount exceeds the amount which Mortgagee will pay as provided below, or shall fail to maintain sufficient funds on deposit as hereinabove provided or to provide a title endorsement or indemnity or surety bond, Mortgagee may, at its option, apply any money so deposited in payment of or on account of such lien, or that part thereof then unpaid, together with all interest thereon. If the amount of money so deposited shall be insufficient for the payment in full of such lien, together with all interest thereon, Mortgagor shall forthwith, upon demand, deposit with Mortgagee a sum which, when added to the funds then on deposit, shall be sufficient to make such payment in full. Mortgagee shall, upon the final disposition of such contest, apply any money so deposited in full payment of such lien or that part thereof then unpaid, together with all interest thereon (provided Mortgagor is not then in default hereunder) when so requested in writing by Mortgagor and when furnished by Mortgagor with sufficient funds to make such payment in full and with evidence satisfactory to Mortgagee of the amount of payment to be made.

3. <u>Indebtedness</u>. "Indebtedness" means all obligations of Borrower or Mortgagor or, if either Borrower or Mortgagor is a land trustee, any beneficiaries of the land trust of which Borrower or Mortgagor is trustee, to Mortgagee for payment of any and all amounts due under the Note or this Mortgage together with any and all other indebtedness now or at any time due and owing from any beneficiary of Mortgagor to Mortgagee, howsoever and whensoever arising or created.

"Indebtedness" also includes all amounts so described herein and all costs of collection, legal expenses and in-house or reasonable outside attorneys' fees incurred or paid by Mortgagee in attempting the collection or enforcement of the Note or this Mortgage, or any extension or modification of this Mortgage or the Note, and guaranty of the Note, or in any legal proceeding occurring by reason of Mortgagee's being the mortgagee under this Mortgage or any extension or modification thereof or the payee under the Note or any extension or modification thereof, including but not limited to any declaratory judgment action, or in the repossession, custody, sale, lease, assembly or other disposition of any collateral for the Note. Notwithstanding anything contained herein to the contrary, in no event shall the lien of this Mortgage secure outstanding liabilities in excess of two hundred percent (200%) of the principal amount of the Note.

- 4. Payment of Taxes. Mortgagor shall pay all general taxes before any penalty interest attaches, and shall pay special taxes, special assessments, water charges, sewer service charges, and all other charges against the Premises of any nature whatsoever when due, and shall, upon written request, furnish to Mortgagee duplicate receipts therefor within thirty (30) days following the date of payment. Mortgagor may pay in full "under protest" any tax or assessment which Mortgagor may desire to contest, in the manner provided by lave. If Mortgagor does not elect to pay under protest, Mortgagor will post such bond or other security as Mortgagee may reasonably require to protect the lien of this Mortgage.
- Tax Deposits. Upon request of Mortgagee, Mortgagor shall deposit with Mortgagee 5. or such depositary ("Depositary") as Mortgagee may from time to time in writing appoint, and in the absence of such appointment, then at the office of Mortgagee together with and in addition to each monthly payment of principal and interest due on the Note, an amount equal to one-twelfth (1/12) of all real estate taxes and assessments (general and special) assessed against the Premises as determined by Mortgagee. Such deposits are to be held without any allowance of interest to Mortgagor and are to be used for the payment of taxes and assessments (general and special) on the Premises next due and payable when they become due. If the funds so deposited are insufficient to pay any such taxes or assessments (general or special) when the same become are and payable, Mortgagor shall, not later than the thirtieth (30th) day prior to the last day on which the same may be paid without penalty or interest, deposit with Mortgagee or the Depositary such additional funds as may be necessary to pay such taxes and assessments (general and special) in full. If the runds so deposited exceed the amount required to pay such taxes and assessments (general and special) for any year, the excess shall be applied on a subsequent deposit or deposits. Said deposits need not be deposited separate and apart from any other funds of Mortgagee or the Depositary.

If any such taxes or assessments (general or special) shall be levied, charged, assessed or imposed upon or for the Premises, or any portion thereof, and if such taxes or assessments shall also be a levy, charge, assessment or imposition upon or for any other premises not encumbered by the lien of this Mortgage, then the computation of any amount to be deposited under this Paragraph 5 shall be based upon the entire amount of such taxes or assessments, and Mortgagor shall not have the right to apportion the amount of any such taxes or assessments for the purposes of such computation.

Insurance. Mortgagor shall keep all buildings and improvements and the Collateral (defined in Paragraph 10 below) now or hereafter situated on said Premises insured against loss or damage by fire, lightning, wind storm, hail storm, aircraft, vehicles, smoke, explosion, riot or civil commotion as provided by the standard all risks policy and against such other hazards as may reasonably be required by Mortgagee, including without limitation of the generality of the foregoing: (a) rent loss or business interruption insurance to cover losses for not less than twelve (12) months; and (b) flood insurance whenever same is available and, in the reasonable opinion of Mortgagee, such protection is necessary. Mortgagor shall also provide insurance coverage with such limits for injury to and death of any person or damage to property of a combined single limit coverage of not less than the Indebtedness secured hereby. All policies of insurance to be furnished hereunder shall be in forms, companies and amounts satisfactory to Mortgagee, with waiver of subrogation and full replacement cost endorsements and a standard non-contributory mortgagee clause attached to all policies, including a provision requiring that the coverage evidenced thereby shall not be terminated or materially modified without thirty (30) days' prior written notice to Mortgagee. Mortgagor shall deliver the original policy to Mortgagee and, in the case of insurance about to expire, shall deliver a certificate evidencing renewal not less than twenty-five (25) days prior to their respective dates of expiration.

Mortgagor shall not take out separate insurance concurrent in form or contributing in the event of loss with that required to be maintained hereunder unless Mortgagee is included thereon under a standard non-contributory mortgagee clause acceptable to Mortgagee. Mortgagor shall immediately notify Mortgagee whenever any such separate insurance is taken out and shall promptly deliver to Mortgagee the original policy of insurance. In the event of a foreclosure of the lien of this Mortgage, or of a transfer of title to the Premises either in lieu of foreclosure or by purchase at the foreclosure sale, all interest in all insurance policies in force shall pass to Mortgagee, transferee or purchaser, as the case may be.

Pursuant to the provisions of 815 ILCS 180/10, Lorrower is hereby notified that unless Borrower provides Mortgagee with evidence of the insurance coverage required hereunder, Mortgagee may purchase insurance at Borrower's expense to proved Mortgagee's interest in the Premises. This insurance may, but need not, protect Borrower's interests. The coverage that Mortgagee purchases may not pay any claim that Borrower makes or any claim that is made against Borrower in connection with the Premises. Borrower may later cancel any insurance purchased by Mortgagee, but only after providing Mortgagee with evidence that Borrower has obtained insurance as required by this Agreement. If Mortgagee purchases insurance for the Premisec, Borrower will be responsible for the costs of that insurance, including interest and any other charges Mortgagee may impose in connection with the placement of such insurance, until the effective date of the cancellation or expiration of such insurance. The costs of such insurance may be added to Borrower's total outstanding balance or obligation. The costs of such insurance may be more than the cost of insurance Borrower may be able to obtain on Borrower's own.

7. <u>Insurance Deposits</u>. Upon request of Mortgagee, Mortgagor shall deposit with Mortgagee or the Depositary for the purpose of providing funds with which to pay premiums when due on all policies of fire and other hazard insurance covering the Premises and the Collateral (defined below), commencing within ten (10) days of such request and on the first day of each month following thereafter, a sum equal to Mortgagee's estimate of the premiums that will next become due and payable on such policies reduced by the amount, if any, then on deposit with Mortgagee or the Depositary, divided by the number of months to elapse before one (1) month prior to the date when such premiums become due and payable. No interest shall be allowed to Mortgagor

on account of any deposit and said deposit need not be kept separate and apart from any other funds of Mortgagee or the Depositary.

- Mortgagee's Interest In and Use of Tax and Insurance Deposits; Security Interest. If an Event of Default (hereafter defined) exists or occurs hereunder, Mortgagee may, at its option but without being required so to do, apply any monies at the time on deposit pursuant to Paragraphs 5 and 7 hereof on any of Mortgagor's obligations contained herein or in the Note, in such order and manner as Mortgagee may elect. When the Indebtedness has been fully paid, any remaining deposits shall be paid to Mortgagor or to the then owner or owners of the Premises as the same appear on the records of Mortgagee. A security interest, within the meaning of the Uniform Commercial Code of the State in which the Premises are located, is hereby granted to Mortgagee in and to all mories at any time on deposit pursuant to Paragraphs 5 and 7 hereof and such monies and all of Mortgagor's right, title and interest herein are hereby assigned to Mortgagee, all as additional security for the indicatedness hereunder and shall, in the absence of an Event of Default (hereafter defined) hereunder, or applied by Mortgagee or Depositary for the direction or control of Mortgagor; provided, however, that reither Mortgagee nor the Depositary shall be liable for any failure to apply to the payment of taxes or assessments or insurance premiums any amount so deposited unless Mortgagor, while no Event of Pefault (hereafter defined) has occurred or exists, shall have furnished Mortgagee with the bills therefor and requested Mortgagee or the Depositary in writing to make application of such funds to the payment of the particular taxes or assessments or insurance premiums for payment of which they were deposited, accompanied by the bills for such taxes or assessments or insurance premiums. Neither Mortgagee rate the Depositary shall be liable for any act or omission taken in good faith, but only for its gross negligence or willful misconduct.
- Adjustment of Losses with Insurer and Application of Proceeds of Insurance. Provided that no default has occurred hereunder or arder the terms of the Note, such insurance proceeds shall be applied to pay for the cost of repair, reounding or restoration of the buildings and other improvements on the Premises. If Mortgagee elects to make said proceeds available to reimburse Mortgagor or any lessee for the cost of repair, rebuilding or restoration of buildings or other improvements on the Premises, such proceeds shall be made available under the terms of a standard construction escrow and shall be disbursed on receipt of architect's certificates, lien waivers and any other documentation or certificates required under the terms of standard construction escrows. If the buildings and other improvements shall be so repaired, resorred or rebuilt, such repaired, restored or rebuilt buildings and other improvements shall be of at least equal value and substantially the same character as prior to such damage or destruction. The prortgagee must approve plans and specifications of such work before such work shall be commenced which approval shall not be unreasonably withheld or denied. If the proceeds are made available by Mortgagee to reimburse Mortgagor or any lessee for the cost of repair, rebuilding or restoration, any proceeds remaining after payment of all costs of such repair, rebuilding or restoration and the reasonable charges of the Disbursing Party (hereinafter defined) shall, be paid to any party entitled thereto as the same appear on the records of Mortgagee. Any proceeds of insurance held by the Disbursing Party shall be invested in an interest-bearing account for the benefit of Mortgagor which is insured by an agency of the United States Government. The risk of loss of such funds, while so invested shall be borne solely by Mortgagor.

As used in the Paragraph 9, the term "Disbursing Party" refers to Mortgagee and to any responsible trust company or title insurance company selected by Mortgagee.

(a) that this Mortgage shall constitute a Security Agreement within the meaning of the Uniform Commercial Code (the "Code") of the State in which the Premises are located with respect to all sums on deposit with Mortgagee pursuant to Paragraphs 5, 7, 9 and 22 hereof ("Deposits") and with respect to any property included in the definition herein of the word "Premises," which property may not be deemed to form a part of the real estate described herein or may not constitute a "fixture" (within the meaning of Section 9-313 of the Code), and all replacements of such property, substitutions for such property, additions to such property, and the proceeds thereof (said property, replacements, substitutions, additions and the proceeds thereof, but specifically excluding all personal property or trade fixtures of any lessee located on the Premises, being sometimes herein collectively referred to as the "Collateral"); and (b) that the Deposits and all of Mortgagor's right, title and interest therein are hereby assigned to Mortgagee; all to secure payment of the Indebtedness and to secure performance by Mortgagor of the terms, covenants and provisions hereof.

If an Event of Pefault (hereafter defined) occurs or exists under this Mortgage, then, in accordance with the previsions of any applicable law, Mortgagee, pursuant to the appropriate provisions of the Code, shall have an option to proceed with respect to both the real property and Collateral in accordance with its rights, powers and remedies with respect to the real property, in which event the default provisions of the Code shall not apply. The parties agree that if Mortgagee shall elect to proceed with respect to the Collateral separately from the real property, ten (10) days written notice of the sale of the Collate at shall be reasonable notice. The reasonable expenses of retaking, holding, preparing for sale, selling and the like incurred by Mortgagee shall include, but not be limited to, reasonable attorneys' fees and legal expenses incurred by Mortgagee. The Mortgagor agrees that, without the written consent of Mortgagee, Mortgagor will not remove or permit to be removed from the Premises any of the Collateral execution that so long as no Event of Default (hereafter defined) exists or occurs hereunder, Mortgagor shall be permitted to sell or otherwise dispose of the Collateral when obsolete, worn out, inadequate, unserviceable or unnecessary for use in the operation of the Premises, but only upon replacing the same or substituting for the same other Collateral at least equal in value and utility to the initial value and utility of that d spoted of and in such a manner that said replacement or substituted Collateral shall be subject to the security interest created hereby and that the security interest of Mortgagee shall be perfected and first in priority, it being expressly understood and agreed that all replacements, substitutions and additions to the Collateral shall be and become immediately subject to the security interest of this Mortgage and covered hereby. The Mortgagor shall, from time to time, on request of Mortgagee, deliver to Mortgagee at the cost of Mortgagor: (a) such further financing statements and security documents and assurances as Mortgagee may require to the end that the liens and security interest created hereby shall be and remain perfected and protected in accordance with the requirements of any present or fu ure law; and (b) an inventory of the Collateral in reasonable detail. The Mortgagor covenants and represents that all Collateral now is, and that all replacements thereof, substitutions therefor or additions thereto, unless Mortgagee otherwise consents, will be free and clear of liens, encumbrances, title retention devices and security interests of others.

The Mortgagor and Mortgagee agree, to the extent permitted by law, that: (a) all of the property described within the definition of the word "Premises" herein are or are to become fixtures on the land described herein; (b) this instrument, upon recording or registration in the real estate records of the proper office, shall constitute a "fixture filing" within the meaning of Sections 9-313 and 9-402 of the Code; and (c) Mortgagor is a record owner of the land described herein.

If the Collateral is sold in connection with a sale of the Premises, Mortgagor shall notify Mortgagee prior to such sale and shall require as a condition of such sale that the purchaser specifically agree to assume Mortgagor's obligations as to the security interests herein granted and to execute whatever agreements and filings are deemed necessary by Mortgagee to maintain Mortgagee's first perfected security interest in the Collateral, Deposits and the deposits described in Paragraph 8 above; provided, however, such notice and condition shall not be required if Mortgagee has agreed to release its lien in the Collateral and the Premises in accordance with Paragraph 23.

11. Stamp Tax; Effect of Changes in Laws Regarding Taxation. If, by the laws of the United States of America or of any state or subdivision thereof having jurisdiction over Mortgagor, any tax is true or becomes due in respect of the issuance of the Note (other than income taxes assessed to Mortgagee), Mortgagor covenants and agrees to pay such tax in the manner required by any such law. Mortgagor further covenants to reimburse Mortgagee for any reasonable sums which Mortgagee may extend by reason of the imposition of any tax on the issuance of the Note.

In the event of the enactment, after this date, of any law of the state in which the Premises are located deducting from the value of the land for the purpose of taxation of any lien thereon, or imposing upon Mortgagee the payment of the whole or any part of the taxes or assessments or charges or liens herein required to be paid by Mortgagor, or changing in any way the laws relating to the taxation of mortgages or debts required by mortgages or Mortgagee's interest in the Premises, or the manner of collection of taxes, so as to affect this Mortgage or the Indebtedness or the holder thereof, then, and in any such event, Mortgagor, upon demand by Mortgagee, shall pay such taxes or assessments or reimburse Mortgagee therefor; provided, however, that if, in the opinion of counsel for Mortgagee: (a) it might be unlawful to require Mortgagor to make such payment; or (b) the making of such payment might result in the imposition of interest beyond the maximum amount permitted by law; then and in any such event, Mortgagor may elect, by notice in writing given to Mortgagor, to declare all of the Indebtedness to be and become due and payable ninety (90) days from the giving of such notice.

12. Observance of Lease Assignment. As additional occurrity for the payment of the Note and for the faithful performance of the terms and conditions contained herein, Mortgagor (and its beneficiary or beneficiaries) has assigned to Mortgagee all of its right, title and interest as landlord in and to the leases listed on the Schedule of Leases attached hereto as Exhibit "B," if any, and all future leases of the Premises. All leases of the Premises are subject to the approval of Mortgagee as to form, content and tenant(s), which approval shall not be unreasonably withheld or deried.

Mortgagor (and Mortgagor's beneficiary) will not, without Mortgagee's prior written consent, which consent shall not be unreasonably withheld or denied: (a) execute any assignment or pledge of any rents or any leases of the Premises except an assignment or pledge securing the Indebtedness; or (b) make any lease of the Premises except for actual occupancy by the tenant thereunder.

Mortgagor, at its sole cost and expense, will: (a) at all times promptly and faithfully abide by, discharge and perform all of the covenants, conditions and agreements contained in all leases of the Premises, on the part of the landlord thereunder to be kept and performed; (b) enforce or secure the performance of all of the covenants, conditions and agreements of such leases on the part of the tenants to be kept and performed, but Mortgagor shall not (and Mortgagor's beneficiary or beneficiaries shall not) modify, amend, cancel, terminate or accept surrender of any lease without the prior written consent of Mortgagee, which consent shall not be unreasonably withheld, except that

such consent is not required for any such action which is in the ordinary course of business and which does not have a material adverse effect on the operation of, or rental income from the Premises; (c) appear in and defend any action or proceeding arising under, growing out of or in any manner connected with such leases or the obligations, duties or liabilities of the landlord or of any tenants thereunder; (d) transfer and assign or cause to be separately transferred and assigned to Mortgagee, upon written request of Mortgagee, any lease or leases of the Premises heretofore or hereafter entered into, and make, execute and deliver to Mortgagee upon demand, any and all instruments required to effectuate said assignment; (e) furnish Mortgagee, within thirty (30) days after a written request by Mortgagee so to do, a written statement containing the names of all tenants and the terms of all leases of the Premises, including the spaces occupied and the rentals payable thereunder; and (f) exercise within thirty (30) days of any written demand therefor by Mortgagee any right to request from the tenant under any lease of the Premises a certificate with respect to the status thereof.

Nothing in this Mortgage or in any other documents relating to the loan secured hereby shall be construed to obligate Mortgagee expressly or by implication, to perform any of the covenants of any landlord under any of the leases assigned to Mortgagee or to pay any sum of money or damages therein provided to be paid by the landlord, each and all of which covenants and payments Mortgagor agrees to perform and pay or cause to be performed and paid.

In the event of the enforcement ry Mortgagee of any remedies provided for by law or by this Mortgage, the tenant under each lease of the Premises shall, at the option of Mortgagee, attorn to any person succeeding to the interest of landlord as a result of such enforcement and shall recognize such successor in interest as landlord under such lease without change in the terms or other provisions thereof; provided, however, that said successor in interest shall not be bound by any payment of any rent or additional rent for more than one month in advance or any amendment or modification to any lease made without the consent of Mortgagee or said successor in interest. Each tenant, upon request by said successor in interest, shall execute and deliver an instrument or instruments confirming such attornment.

Mortgagee shall have the option to declare this Mortgage in default because of a material default of landlord beyond all applicable cure periods in any lease of the Premises, whether or not such default is cured by Mortgagee pursuant to the right granted herein. It is covenanted and agreed that a default under any Assignment of Rents or Leases executed pursuant to this Paragraph 12 shall constitute an Event of Default hereunder after expiration of all applicable notice and grace periods, on account of which the whole of the Indebtedness secured hereby shall at once, at the option of Mortgagee, become immediately due and payable, without notice to Mortgagee.

Mortgager and Lien Not Released. From time to time, Mortgager may, at Mortgager's option, without giving notice to or obtaining the consent of Mortgagor or Mortgagor's successors or assigns or the consent of any junior lienholder, guarantor or tenant, without liability on Mortgagee's part and notwithstanding Mortgagor's breach of any covenant, agreement or condition: (a) release anyone primarily or secondarily liable on any of the Indebtedness; (b) accept a renewal note or notes therefor; (c) release from the lien of this Mortgage any part of the Premises; (d) take or release other or additional security for the Indebtedness; (e) consent to any plat, map or plan of the Premises; (f) consent to the granting of any easement; (g) join in any extension or subordination agreement; (h) agree in writing with Mortgagor to modify the rate of interest or period of amortization of the Note or change the time of payment or the amount of the monthly installments payable thereunder; and (i) waive or fail to exercise any right, power or remedy granted by law or

herein or in any other instrument given at any time to evidence or secure the payment of the Indebtedness.

Any actions taken by Mortgagee pursuant to the terms of this Paragraph 13 shall not impair or affect: (a) the obligation Mortgagor or Mortgagor's successors or assigns to pay any sums at any time secured by this Mortgage and to observe all of the covenants, agreements and conditions herein contained; (b) the guaranty of any individual or legal entity for payment of the Indebtedness; and (c) the lien or priority of the lien hereof against the Premises. Mortgagor shall pay to Mortgagee a reasonable service charge and such title insurance premiums and reasonable attorneys' fees as may be incurred by Mortgagee for any action described in this Paragraph 13 taken at the request of Mortgagor or its beneficiary or beneficiaries.

- 14. Mortgagee's Reliance on Tax Bills, etc. Mortgagee in making any payment hereby authorized: (a) telating to taxes and assessments, may do so according to any bill, statement or estimate procured from the appropriate public office without inquiry into the validity of any tax, assessment, sale, forfetture, tax lien or title or claim thereof; or (b) for the purchase, discharge, compromise or settlement of any other prior lien, may do so without inquiry as to the validity or amount of any claim for lien which may be asserted.
- Acceleration of Indebtedness in Case of an Event of Default. An "Event of **Default**" shall mean the following: (a) If Borrower shall fail to make due and punctual payment of principal or interest on the Note when and at the same shall become due, or any other payment due in accordance with the terms thereof beyond all applicable cure periods (which terms are hereby incorporated by reference); or (b) if Borrowe: Mortgagor (or for any beneficiary thereof) or any guarantor of the Note shall file (i) a petition for liquidation, reorganization or adjustment of debt under Title 11 of the United States Code (11 U.S.C. \$107 et seq.) or any similar law, state or federal, whether now or hereafter existing, or (ii) any answer admitting insolvency or inability to pay its debts, or (iii) fail to obtain a vacation or stay of involuntary proceedings within sixty (60) days, as hereinafter provided; or (c) any order for relief for Borrower or Mortgagor (or for any beneficiary thereof) or for any guarantor of the Note shall be entered in any case under Title 11 of the United States Code, or a trustee or a receiver shall be appointed for the Borrover or Mortgagor (or for any beneficiary thereof) or for any guarantor of the Note in any voluntary or involuntary proceeding, or any court shall have taken jurisdiction of all or the major part of the precerty for Borrower or Mortgagor (or for any beneficiary thereof) or for any guarantor of the Note in any voluntary or involuntary proceeding for the reorganization, dissolution, liquidation, adjustment or liebt or winding up of Borrower or Mortgagor (or of any beneficiary thereof) or of any guarantor of the Note and such trustee or receiver shall not be discharged or such jurisdiction not be relinquished or vecated or stayed on appeal or otherwise stayed within sixty (60) days; or (d) Borrower or Mortgago: (or any beneficiary thereof) or any guarantor of the Note secured hereby shall make an assignment for the benefit of creditors, or shall admit in writing its inability to pay its debts generally as they become due, or shall consent to the appointment of a receiver or trustee or liquidator of all or any major part of its property; or (e) Mortgagor shall fail to observe or perform any other covenant, agreement or condition set forth herein and required to be kept or performed or observed by Mortgagor (or its beneficiary), which failure is not cured within thirty (30) days after written notice thereof, provided that, if Mortgagor acts diligently, continuously in good faith to cure such failure within such thirty (30) day period after written notice and such failure cannot reasonably be cured within such time period, then such time period shall be extended; or (f) if Borrower or Mortgagor (and their respective beneficiaries) shall fail to observe or perform any covenant, agreement or condition required to be kept or observed by Borrower or Mortgagor (or their respective beneficiaries) or any guarantor in

If an Event of Default shall exist or occur, then the whole of the Indebtedness shall at once, at the option of Mortgagee, become immediately due and payable without notice to Mortgagor. If while any insurance proceeds or condemnation awards are held by or for Mortgagee to reimburse Mortgagor or any lessee for the cost of repair, rebuilding or restoration of building(s) or other improvements on the Premises, as set forth in Paragraphs 9 and 22 hereof, Mortgagee shall be or become entitled to accelerate the maturity of the Indebtedness, then and in such event, Mortgagee shall be entitled to apply all such insurance proceeds and condemnation awards then held by or for it in reduction of the Indebtedness, and any excess held by it over the amount of the Indebtedness shall be paid to Mortgagor or any party entitled thereto, without interest, as the same appear on the records of Mortgagee.

Foreclusive; Expense of Litigation. In any civil action to foreclose the lien hereof, there shall be allowed and included as additional Indebtedness in the order or judgment for foreclosure and sale all reasonable expenditures and expenses which may be paid or incurred by or on behalf of Mortgagee for reasonable attorneys' fees, appraiser's fees, special process server fees, outlays for documentary and expert evidence, stenographers' charges, publication costs, and costs (which may be estimated as to items to 12 expended after entry of said order or judgment) of procuring all such abstracts of title, title searche; and examination, title insurance policies and similar data and assurances with respect to the title as Mortgagee may deem reasonably necessary either to prosecute such civil action or to evidence to bidders at any sale which may be had pursuant to such order or judgment the true condition of the title to, or the value of the Premises. All reasonable expenditures and expenses of the nature in this Paragraph mentioned and such reasonable expenses and fees as may be incurred in the protection of the Premises and the maintenance of the lien of this Mortgage, including the reasonable fees of any attorneys employed by Mortgagee in any litigation or proceeding affecting this Mortgage, the Note or the Premises, including probate, appellate and bankruptcy proceedings, or in preparations for the commencement or defense of any action or proceeding or threatened action or proceeding, shall be immediately due and payable by Mortgagor, promptly on receipt of a statement, with interest thereon at the rate set forth in the Note applicable to a period when a default exists thereunder, and shall be secured by this Mortgage.

At all times, Mortgagor shall appear in and defend any suit, action or proceeding that might in any way in the sole judgment of Mortgagee affect the value of the Premises, the priority of this Mortgage or the rights and powers of Mortgagee hereunder or under any document given at any time to secure the Indebtedness. Mortgagor shall, at all times, indemnify, hold harmless and reimburse Mortgagee on demand for any and all loss, damage, expense or cost, including cost of evidence of title and attorneys' fees, arising out of or incurred in connection with any proceeding in which Mortgagee is held to have been liable as a result of negligence or willful act of Mortgagor.

17. Application of Proceeds of Foreclosure Sale. The proceeds of any foreclosure sale of the Premises shall be distributed and applied in the following order of priority: first, on account of all costs and expenses incident to the foreclosure proceedings, including all such items as are mentioned in the preceding Paragraph hereof; second, all other items which may under the terms hereof constitute secured Indebtedness additional to that evidenced by the Note, with interest thereon

as herein provided; third, all principal and interest remaining unpaid on the Note; and fourth, any overplus to any party entitled thereto as their rights may appear.

- 18. Appointment of Receiver or Mortgagee in Possession. Upon, or at any time after, the commencement of an action to foreclose this Mortgage, the court in which such action was commenced may, upon request of Mortgagee, appoint a receiver of the Premises either before or after foreclosure sale, without notice and without regard to the solvency or insolvency of Mortgagor at the time of application for such receiver and without regard to the then value of the Premises or whether the same shall be then occupied as a homestead or not; and Mortgagee or any holder of the Note may be appointed as such receiver or as Mortgagee in possession. All monies paid for any of the purposes herein authorized and all reasonable expenses paid or incurred in connection to rewith, including reasonable attorneys' fees, and any other monies advanced by Mortgagee in regard to any tax referred to in Paragraph 11 or to protect the Premises or the lien hereof, shall be so much additional Indebtedness secured hereby, and shall become immediately due and payable without notice and with interest thereon at the rate of interest set forth in the Note applicable to a period when a default exists thereunder. Inaction of Mortgagee shall never be considered as a waiver of any right accruing to it on account of any default on the part of Mortgagor.
- Rights Cumulative. Each right, power and remedy conferred upon Mortgagee by this Mortgage and by all other documents evidencing or securing the Indebtedness and conferred by law and in equity is cumulative and in addition to every other right, power and remedy, express or implied, given now or hereafter existing, at law and in equity; and each and every right, power and remedy herein or therein set forth or otherwise so existing may by exercised from time to time as often and in such order as may be deemed expedient by Mortgagee; and the exercise or the beginning of the exercise of any right, power or remedy shall not be a waiver of the right to exercise at the same time or thereafter any other right, power or remedy; and no delay or omission of, or discontinuance by, Mortgagee in the exercise of any right, power or remedy accruing hereunder or arising otherwise shall impair any such right, power or remedy, or be construed to be a waiver of any default or acquiescence therein.

- 21. <u>Mortgagee's Right of Inspection</u>. Mortgagee shall have the right to inspect the Premises at all reasonable times upon reasonable advance notice to Mortgagor, and access thereto shall be permitted for that purposes.
- the entire proceeds of any claim for damages for any of the Premises taken or damaged under the power of eminent domain or by condemnation to the extent of the Indebtedness secured hereby. So long as: (a) each lease listed on the Schedule of Leases attached hereto as Exhibit B, if any, and all future leases of the Premises are in full force and effect and each tenant thereunder is not in default and such taking shall not result in the termination or cancellation of any of those leases or give any tenant thereunder the right to cancel its lease; (b) the Premises require repair, rebuilding or restoration; and (c) an Event of Default has not occurred; then any award, after deducting therefrom any expenses incurred in the collection thereof, shall be made available by Mortgagee for the repair, rebuilding or restoration of the Premises in accordance with plans and specifications to be submitted to and approved by Mortgagee in its reasonable judgment.

 - (c) any sale, conveyance, assignment, or other transfer of, or the grant of a security interest in, any general partnership interest in any limited partnership or general partnership which is the beneficiary or one of the beneficiaries under the trust agreement with Mortgagor.

Any consent by Mortgagee, or any waiver of an Event of Default under this Paragraph shall not constitute a consent to, or waiver of, any right, remedy or power of Mortgagee upon a subsequent Event of Default under this Paragraph.

Leases entered into in the ordinary course of Beneficiary's business on lease forms previously approved in writing by Mortgagee and at rental rates not less than those prevailing in the market place at the time of execution of the lease shall be deemed a permitted transfer of title and not an Event of Default.

- Binding Nature. This Mortgage and all provisions hereof shall extend to and be binding upon the original Mortgagor named on page one (1) hereof and its successors, grantees, assigns, each subsequent owner or owners of the Premises and all persons claiming under or through Mortgagor; and the word "Mortgagor" when used herein shall include all persons primarily and secondarily liable for the payment of the Indebtedness or any part thereof, whether or not such persons shall have executed the Note or this Mortgage.
- 32. Release of Previous Holder. The word "Mortgagee" when used herein shall include the successors and assigns of the original Mortgagee named on page one (1) hereof, and the holder or holders, from time to time, of the 'vote. However, whenever the Note is sold, each prior holder shall be automatically freed and relieved, on and after the date of such sale, of all liability with respect to the performance of each covenant and obligation of Mortgagee hereunder thereafter to be performed, provided that any monies in which Mortgager has an interest, which monies are then held by the seller of the Note, are turned over to the purchaser of the Note.
- 33. Severability and Applicable Law.
