Any amounts disbursed by Lender under this Section 9 chal become additional debt of Borrower secured by this Security Instrument. These amounts shall bear interest at the Note at from the date of disbursement and shall be payable, with such interest, upon notice from Lender to Borrower requesting payr ent.

If this Security Instrument is on a leasehold, Borrower shall comply with all the provisions of the lease. If Borrower acquires fee title to the Property, the leasehold and the fee title shall not merge uniess Lender agrees to the merger in writing.

require the mortgage insurer to make payments using any source of funds that the mortgage insurer may have available (which may includ, funds obtained from Mortgage Insurance premiums).
