THIS CONDOMINIUM RIDER is made this 14th day of April 2005 , and is incorporated into and shall be deemed to amend and supplement the Mortgage, Deed of Trust, or Security Deed (the "Security Instrument") of the same date given by the undersigned (the "Borrower") to secure Borrower's Note to St. Francis Mortgage Corporation, a Illinois Corporation
