MORTGAGE

This Mortgage is made as of October 20, 2005, by Chris Garrett (referred to as "Mortgagor") in favor of 1201 South Western, LLC, (Mortgagee), whose mailing address is 7039 West Roosevelt, Berwyn, Illinois.

WHEREAS, Mortgagor is justly indebted to Mortgagee, including, without limitation, the principal sum of TWO HUNDREL NINETY ONE THOUSAND TWO HUNDRED 00/100 DOLLARS (\$291,200), and such additional advances as Mortgagee may from time to time extend to Mortgagor not to exceed ONE MILLION DOLLARS, as evider call by a certain promissory note of even date herewith (Note) and any other notes that may be executed as advances are made, all such notes made payable to the order of and delivered to Mortgagee, whereby the obligor promises to pay the Note, late charges, prepayment premiums (if any), and interest at the rate or rates provided in the Note. The final ray ment of principal and interest, if not sooner paid, renewed, modified, extended, or renegotiated, shall be due on the date stated in the Note. All such payments on account of the indebtedness secured hereby shall be applied first to interes on he unpaid principal balance of the Note, secondly to any other sums due thereunder, third to all other advances and sums secured hereby, and the remainder to principal.

WHEREAS, Mortgagor, in order to secure the payment of said principal sum of money and said interest and late charges and prepayment premiums, if any sees, and expenses, in accordance with the terms, provisions, and limitations of this Mortgage and of the Note, either directly or indirectly as evidenced by a guaranty of payment of performance executed by Mortgagor or a beneficiary of Mortgagor and the performance of the covenants and agreements herein contained by Mortgagor to be performed, as security for repayment of any and all other liabilities and obligations of Mortgagor or its beneficiary now or hereafter due Mortgagee, whether direct or indirect, absolute or contingent, primary or secondary, joint or several, and in consideration of the sum of \$10 in hand paid, the receipt of which is hereby acknowledged, does by these presents mortgage, grant, remise, release, alien, and convey unto Mortgagee and its successors and assigns the following described rear estate and all of its present and hereafter acquired estate, right, title, and interest therein, lying and being in the County of Cook and State of Illinois to wit: 5656 South Indiana, Chicago, Illinois, PIN # 20-15-109-055-0000

The property hereinafter described, is collectively referred to herein as the 'Premises,' TOGETHER with all improvements, tenements, reversions, remainders, easements, fixtures and appurtenences now or hereafter thereto belonging, and all rents, issues, and profits thereof for as long as and during all such time; as Mortgagor may be entitled thereto (which are pledged primarily and on a parity with the real estate and not percendarily); all tenant security deposits, utility deposits, and insurance premium rebates to which Mortgagor may be entitled or that Mortgagor may be holding; and all fixtures, apparatus, equipment, and articles (other than inventories held for sale) that relate to the use, occupancy, and enjoyment of the Premises. All of the land, estate, and property hereinabove described, real, personal, and mixed, whether affixed or annexed or not (except where otherwise hereinabove specified) and all rights hereby conveyed and mortgaged are intended to be as a unit and are hereby understood, agreed, and declared (to the maximum extent permitted by law) to form part and parcel of the real estate and to be appropriated to the use of the real estate and shall be, for the purposes of this Mortgage, deemed to be real estate and conveyed and mortgaged hereby.

TO HAVE AND TO HOLD the Premises unto Mortgagee and its successors and assigns forever, for the purpose and uses herein set forth.

IT IS FURTHER UNDERSTOOD AND AGREED THAT:

1. MAINTENANCE, REPAIR, AND RESTORATION OF IMPROVEMENTS, PAYMENT OF PRIOR LIENS, ETC. Mortgagor shall (a) promptly repair, restore, or rebuild any buildings and other improvements now or hereafter on the Premises that may become damaged or destroyed to substantially the same character as prior to such damage or destruction, without regard to the availability or adequacy of any casualty insurance proceeds or eminent domain awards; (b) keep the Premises constantly in good condition and repair, without waste; (c) keep the Premises free from mechanics liens or other liens or claims for lien not expressly subordinated to the lien hereof (collectively called "Liens"), subject, however, to the rights of Mortgagor set forth in the next Paragraph below; (d) immediately pay when due any indebtedness that may be secured by a lien or charge on the Premises on a parity with or superior to the lien hereof (no such subsequent lien to be permitted hereunder) and upon request exhibit satisfactory evidence of the discharge of such lien to Mortgagee; (e) complete within a reasonable time any buildings or other improvements now or at any time in process of erection on the Premises; (f) comply with all federal, state, and local requirements of law, regulations, ordinances, orders, and judgments and all covenants, easements, and restrictions of record with respect to the Premises and the use thereof; (g) make no alterations in the Premises without Mortgagee's prior written consent; (h) suffer or permit no change in the general nature of the occupancy of the Premises without Mortgagee's prior written consent (i) observe and comply with all conditions and requirements (if any) necessary to preserve and extend all rights, assements, licenses, permits (including without limitation zoning variations and any nonconforming uses and structures), privileges, Franchises, and concessions applicable to the Premises or contracted for in connection with any present or future use of the Premises; and (j) pay each item of indebtedness secured by this Mortgage when due according to the terms hereof and of the Note. As used in this Paragraph and elsewhere in the Mortgage, the term "Indebtedn ss" means and includes the unpaid principal sum evidenced by the Note, together with all interest, additional interest, late charges, and prepayment premiums thereon (if any), and all other sums at any time secured by this Mortgage. Anytling in (c) and (d) above to the contrary notwithstanding, Mortgagor may, in good faith and with reasonable diligence, for test the validity or amount of any lien not expressly subordinated to the lien hereof and defer payment and discharge thereof during the pendency of such contest, provided that (i) such contest shall have the effect of preventing the sale or forfeiture of the Premises or any part thereof, or any interest therein, to satisfy such lien; (ii) within ten days after Mortgagor has been notified of the assertion of such lien, Mortgagor shall have notified Mortgagee in writing of Mortgagor's intention to contest that lien; and (iii) Mortgagor shall have deposited with Mortgagee a sum of money that shall be sufficient in the judgment of Mortgagee to pay in full the lien and all interest that might become due thereon, and shall keep on deposit an amount so sufficient at all times, increasing the amount to cover additional interest whenever, in the judgment of Mortgagee, such increase is advisable. Such deposits are to be held without any allowance of in e.est. If Mortgagor shall fail to prosecute such contest with reasonable diligence or shall fail to pay the amount of 'ne I en plus any interest, cost, and expenses finally determined to be due upon the conclusion of such contest, to the extent that amount exceeds the amount that Mortgagee will pay as provided below or shall fail to maintain sufficient funds on deposit as hereinabove provided, Mortgagee may, at its option, apply the money so deposited in payment of or or such lien, or that part thereof then unpaid, together with all interest thereon. If the amount of money so deposited shall be insufficient for the payment in full of the lien, together with all interest thereon, Mortgagor shall, upon demand, deposit with Mortgagee a sum that, when added to the funds then on deposit, shall be sufficient to make such payment in full. Mortgagee shall, upon the final disposition of the contest, apply the money so deposited in full payment of the lien or that part thereof then unpaid (provided Mortgagor is not then in default hereunder) when so requested in writing by Mortgagor and when furnished by Mortgagor with sufficient funds to make such payment in full and with evidence satisfactory to Mortgagee of the amount to be paid.

2. PAYMENT OF TAXES. Mortgagor shall pay all general taxes before any penalty or interest attaches, and shall pay special taxes, special assessments, water charges, sewer service charges, and all other charges against the Premises of any nature whatsoever when due, and shall, upon written request, furnish to Mortgagee duplicate receipts thereof within 30 days following the date of payment. Mortgagor shall pay in full, under protest, any tax or assessment that Mortgagor may desire to contest, in the manner provided by law.

3. TAX DEPOSITS. Unless waived from time to time by Mortgagee in writing, Mortgagor shall deposit with Mortgagee, commencing on the date of disbursement of the proceeds of the loan secured hereby and on the first day of each month following the month in which the disbursement occurs (unless otherwise agreed to by Mortgagee), a sum equal to the amount of all real estate taxes and assessments (general and special) next due on or for the Premises (the amount of such taxes next due to be based on Mortgagee's reasonable estimate as to the amount of taxes and assessments to be levied and assessed) reduced by the amount, if any, then on deposit with Mortgagee, divided by the number of months to elapse before two months prior to the date when such taxes and assessments first become due and payable. Such deposits are to be held without any allowance or payment of interest to Mortgagor and are to be used for the payment of taxes and assessments (general and special) on the Premises next due and payable when they become due. If the funds so deposited are insufficient to pay any such taxes or assessments (general or special) when they become due and payable, Mortgagor shall, within ten days after receipt of demand therefor from Mortgagee, deposit such additional funds as may be necessary to pay the taxes and assessments (general and special) in full. If the funds so deposited exceed the amount required to pay the taxes and assessments (general and special) for any year, the excess shall be applied on a subsequent deposit or deposits. These deposits need not be kept separate and apart from any other funds of Mortgagee.

Anything in this Paragraph 3 to the contrary notwithstanding, if the funds so deposited are insufficient to pay any such taxes or assessments (general or special) or any installment thereof, Mortgagor will, not later than the 30th day prior to the last day on which the taxes or assessments may be paid without penalty or interest, deposit with Mortgagee the full amount of any such deficiency.

If any such taxes or assessments (general or special) shall be levied, charged, assessed, or imposed on or for the Premises, or any portion thereof, and if such taxes or assessments shall also be a levy, charge, assessment, or imposition on or for any other premises not encumbered by the lien of this Mortgage, then the computation of any amount to be deposited under this Paragraph 3 shall be based on the entire amount of such taxes or assessments, and Mortgagor shall not have the right to apport on the amount of any such taxes or assessments for the purpose of this computation.

- 4. INSURANCE DEPOSITS. For the purpose of providing funds with which to pay premiums when due on all policies of fire and other hazard insurance covering the Premises and the Collateral (defined below) and unless waived from time to time by Mortgagee in writing, Mortgage? chall deposit with Mortgagee, commencing on the date of disbursement of the proceeds of the loan secured hereby and or the first day of each month following the month in which the disbursement occurs (unless otherwise agreed to by Mortgagee), a sum equal to Mortgagee's estimate of the premiums that will next become due and payable on such policies reduced by the amount, if any, then on deposit with Mortgagee, divided by the number of months to elapse before two mortins prior to the date when such premiums become due and payable. No interest shall be allowed or paid to Mortgagor on account of any deposits made hereunder, and these deposits need not be kept separate and apart from any other funds of Mortgagee.
- 5. MORTGAGEE'S, INTEREST IN AND USE OF TAX AND INSURANCE DEPOSITS; SECURITY INTEREST. In the event of a default hereunder, Mortgagee may, at its option but without being required so to do, apply any money at the time of deposit pursuant to Paragraphs 3 and 4 hereof on any of Mortgagor's colligations contained herein or in the Note, in such order and manner as Mortgagee may elect. When the Indebtedne's has been fully paid, any remaining deposits shall be paid to Mortgagor or to the then owner or owners of the Premises as they appear on the records of Mortgagee. A security interest, within the meaning of the Uniform Commercial Code of the State in which the Premises are located, is hereby granted to Mortgagee in and to all money at any time on deposit pursuant to Paragraphs 3 and 4 hereof, and this money and all of Mortgagor's right, title, and interest are hereby assigned to Mortgagee, all as additional security for the indebtedness hereunder and shall, in the absence of default hereunder, be applied by Mortgagee for the purposes for which made hereunder and shall be subject to the direction or control of Mortgagor; provided, however, that Mortgagee shall not be liable for any failure to apply to the payment of taxes or assessments or insurance premiums any amount so deposited unless Mortgagor, while not in default hereunder, shall have furnished Mortgagee with the bills therefore and requested Mortgagee in writing to make application of such funds to the payment of the particular taxes or assessments or insurance premiums for payment of which they were deposited, accompanied by the bills for such taxes or assessments of insurance premiums. Mortgagee shall not be liable for any act or omission taken in good faith, but only for its gross negligence or willful misconduction

6. INSURANCE. Mortgagor shall keep all buildings and improvements and the Collateral (defined in Paragraph 28 below) now or hereafter situated on the Premises insured against loss or damage by fire on a so-called "All Risks" basis and against such other hazards as may reasonably be required by Mortgagee, including without limitation of the generality of the foregoing (a) rent loss or business interruption insurance whenever, in the opinion of Mortgagee, such protection is necessary, and (b) flood insurance whenever it is available and, in the opinion of Mortgagee, such protection is necessary. Mortgagor shall also provide insurance coverages with such limits for personal injury, death, and property damage as Mortgagee may require. All policies of insurance to be furnished hereunder shall be in forms, companies, and amounts satisfactory to Mortgagee, with waiver of subornation and replacement cost endorsements and a standard non-contributory mortgagee clause attached to all policies, including a provision requiring that the coverages evidenced thereby shall not be terminated or materially modified without 30 days' prior written notice to Mortgagee. Mortgagor shall deliver all original policies, including additional and renewal policies, to Mortgagee and, in the case of insurance about to expire, shall deliver renewal policies not less than 30 days prior to their respective dates of expira ion. Mortgagor shall not take out separate insurance concurrent in form or contributing in the event of loss with that required to be maintained hereunder unless Mortgagee is included thereon under a standard noncontributory mortgagee clause acceptable to Mortgagee. Mortgagor shall immediately notify Mortgagee whenever any such separate incurance is taken out and shall promptly deliver to Mortgagee the original policy or policies of such insurance. In the event of a foreclosure of the Mortgage, or of a transfer of title to the Premises either in lieu of foreclosure or by purchase at the foreclosure sale, all interest in all insurance policies in force shall pass to Mortgagee, transferee, or purchaser, as the case may be. Within 90 days following the end of each fiscal year of Mortgagor, at the request of Mortgagoe, Mortgagor agrees to furnish evidence of replacement cost, without cost to Mortgagee, such as are regularly and ordinarily made by insurance companies to determine the then replacement cost of the buildings and other improvements on the Premises.

7. ADJUSTMENT OF LOSSES WITH INSURER AND APPLICATION OF PROCEEDS OF INSURANCE.

In case of the loss or damage by fire or oth a casualty, Mortgagee is authorized (a) to settle and adjust any claim under insurance policies that insure such risks, or (b) to allow Mortgagor to agree with the insurance company or companies on the amount to be paid in regard to such loss. In either case, Mortgagee is authorized to collect and receipt for any such insurance money. As long as (a) each least applicable to the premises is in full force and effect and each tenant thereunder is not in default and such loss or dar as shall not result in the termination or cancellation of any of those leases or give any tenant thereunder the right to terminate or cancel its lease; (b) no insurer denies liability as to any insured or claims any right of participation in any of Mor gagee's security; and (c) this Mortgage is not in default, then such insurance proceeds, after deducting therefron: any expense incurred by Mortgagee in the collection thereof, shall be made available by Mortgagee for the repair, rebuilding, or restoration of the buildings and other improvements on the Premises. In any event, the buildings and other improvements shall be repaired, restored, or rebuilt so as to be of at least equal value and substantially the same character as prior to such damage or destruction. If the insurance proceeds are made available for repair, rebuilding, or rectoration, they shall be disbursed upon the "Disbursing Party" (hereinafter defined) being furnished with satisfactory evidence of the cost of completion thereof and with architects' certificates, waivers, or liens, contractors' and s'icontractors' sworn statements, title continuations, and other evidence of cost and payments so that Disbursing Face can verify that the amounts disbursed from time to time are represented by completed and in-place work and that the work is free and clear of mechanics lien claims. No payment made prior to the final completion of the work shall exceed 90 percent of the value of the work performed from time to time, and at all times the undisbursed balance of such proceeds remaining in the hands of Disbursing Party shall be at least sufficient to pay for the cost of completion of the work free and clear of liens. If the cost of rebuilding, repairing, or restoring the buildings and other improvements may reasonably exceed the sum of \$50,000, then Mortgagee must approve plans and specifications of the work before the work shall be commenced. Any surplus that may remain out of these insurance proceeds, after payment of the cost of repair, rebuilding, and restoration and the reasonable charges of Disbursing Party, shall, at the option of Mortgagee, be applied on account of the indebtedness or paid to any party entitled thereto as they appear on the records of Mortgagee. No interest shall be allowed to Mortgagor on any proceeds of insurance held by Disbursing Party. As used in this Paragraph 7, the term "Disbursing Party" refers to Mortgagee and/or any title insurance company selected by Mortgagee.

8. STAMP TAX; EFFECT OF CHANGES IN LAWS REGARDING TAXATION. If, by the laws of the United States of America or of any state or subdivision thereof having jurisdiction over Mortgagor, any tax is due or becomes due in respect to the Note or this Mortgage, Mortgagor covenants and agrees to pay the tax in the manner required by any such law. Mortgagor further covenants to reimburse Mortgagee for any sums that Mortgagee may expend by reason of the imposition of any tax on the issuance of the Note. In the event of the enactment of any law of the state in which the Premises are located imposing on Mortgagee the payment of the whole or any part of taxes, assessments, or charges on the lien of this Mortgage, or changing in any way the laws relating to the taxation of mortgages or debts secured by mortgages or Mortgagee's interest in the Premises, or the manner of collection of taxes, so as to affect this Mortgage or the debt secured hereby or the holder thereof, then, and in any such event, Mortgagor, upon demand by Mortgagee, shall pay such taxes or assessments or reimburse Mortgagee therefore; provided, however, that if in the opinion of counsel for Mortgagee (a) it might be unlawful to require Mortgagor to make such payment; or (b) the making of such payment might result in the imposition of interest beyond the maximum amount permitted by law; then, and in such event, Mortgagee may elect, by notice in writing given to Mortgagor, to declare all of the indebtedness to be and become due and payable 60 days from the giving of such notice.

9. OBSERVANCE OF LEASE ASSIGNMENT. As additional security for the payment of the Note and for the faithful performance of the terms and conditions contained herein, Mortgagor and its beneficiaries do hereby assign to Mortgagee all of their right, title, and interest as landlords in and to the present leases and all future leases of the Premises. All leases of the Promises are subject to the approval of Mortgagee as to form, content, and tenant. Mortgagor will not and Mortgagor's beneficiaries will not, without Mortgagee's prior written consent (a) execute an assignment or pledge of any rents of any leases of the Premises except an assignment or pledge securing the Indebtedness in favor of Mortgagee; (b) accept any payment of any installment of rent more than 30 days before the due date thereof; or (c) make any lease of th: Premises except for actual occupancy by the tenant thereunder. Mortgagor shall not and the beneficiaries of Mortgagor, if any, shall not enter into or permit to be entered into any management contract, assignment, or sublease of any lease, license, or concession pertaining to the Premises without the prior written approval of Mortgagee having first been obtained and following such approval shall not amend or modify the document without further written approval of Mortgagee. Mortgager at its sole cost and expense will (a) at all times promptly and faithfully abide by, discharge, and perform all of the covenants, conditions, and agreements contained in all leases of the Premises, on the part of the landlord the reunder to be kept and performed; (b) enforce or secure the performance of all the covenants, conditions, and agreer on such leases on the part of the tenants to be kept and performed, but Mortgagor shall not and Mortgagor's be efficiaries shall not modify, amend, cancel, terminate, or accept surrender of any lease without prior written consent of Mortgagee; (c) appear in and defend any action or proceeding arising under, growing out of, or in any manner connected with such leases or obligations, duties, or liabilities of the landlord or of any tenants thereunder; (d) transfer and assign or cause to be separately transferred and assigned to Mortgagee, upon written request of Mortgagee, any lase or leases of the Premises heretofore or hereafter entered into, and make, execute, and deliver to Mortgagee upon demand any and all instruments required to effect the assignment; (e) furnish Mortgagee, within ten days after a request by Mortgagee so to do, a written statement containing the names of all tenants and the terms of all leases of the Promises, including the spaces occupied and the rentals payable thereunder; and (f) exercise within five days of any demand therefore by Mortgagee any right to request from the tenant under any lease of the Premises a certificate with respect to the status thereof. Nothing in this Mortgage or in any other documents relating to the Note secured hereby shall be construed to obligate Mortgagee, expressly or by implication, to perform any of the covenants of the landlord under any of the leases assigned to Mortgagee or to pay any sum of money or damages therein provided to be paid by the landlord, each and all of which covenants and payments Mortgagor agrees to perform and pay or cause to be performed and paid. At the option of Mortgagee, this Mortgage shall become subject and subordinate, in whole or in part (but not with respect to priority of entitlement to insurance proceeds or any award in eminent domain), to any one or more leases affecting any part of the Premises, upon the execution by Mortgagee and recording or registration thereof, at any time hereafter, in the office in which this Mortgage was registered or filed for record, of a unilateral declaration to that effect. In the event of the enforcement by Mortgagee of any remedies provided for by law or by this Mortgage, the tenant under each lease of the Premises shall, at the option of Mortgagee, attorn to any person succeeding to the

interest of landlord as a result of such enforcement and shall recognize the successor in interest as landlord under the lease without change in the terms or other provisions thereof; provided, however, that the successor in interest shall not be bound by any payment of rent or additional rent for more than one month in advance or any amendment or modification to any lease made without the consent of Mortgagee or the successor in interest. Each tenant, upon request by the successor in interest, shall execute and deliver an instrument or instruments confirming such attornment. Mortgagee shall have the option to declare this Mortgage in default because of a material default of landlord in any lease of the Premises, whether or not such default is cured by Mortgagee pursuant to the right granted herein. It is covenanted and agreed that a default under any Assignment of Rents or Leases executed pursuant to this Paragraph 9, or otherwise, shall constitute a default hereunder, on account of which the whole of the Indebtedness secured hereby shall at once, at the option of Mortgagee, become immediately due and payable, without notice to Mortgagor.

10. MORTGAGOR AND LIEN NOT RELEASED. From time to time Mortgagee may, at Mortgagee's option, without giving notice to or obtaining the consent of Mortgagor, its beneficiaries, or its successors or assigns or the consent of any innior lien holder, grantor, or tenant, without liability on Mortgagee's part and notwithstanding Mortgagor's breach of any covenant, agreement, or condition, (a) release anyone primarily or secondarily liable on any of the Indebtedness, (b) accept a renewal note or notes of the Note; (c) release from the lien of this Mortgage any part of the Premises; (d) to'le or release other or additional security for the indebtedness; (e) consent to any plat, map, or plan of the Premises or Declaration of Condominium as to the Premises (in whole or in part); (f) consent to the granting of any easement; (g) jc n in any extension or subordination agreement; (h) agree in writing with Mortgagor to modify the rate of interest or period of amortization of the Note or change the time of payment or the amount of the installments payable thereunder; at d (i) waive or fail to exercise any right, power, or remedy granted by law or in this Mortgage or in any other instrument given at any time to evidence or secure the payment of the indebtedness. Any actions taken by Mortgagee pursuant to the terms of this Paragraph 10 shall not impair or affect (a) the obligation of Mortgagor or Mortgagor's successors or assigns to pay any sums at any time secured by this Mortgage and to observe all of the covenants, agreements, and conditions herein contained; (b) the guaranty of any individual or legal entity for payment of the indebtedness; and (c) the lien or priority of the lien hereof against the Premises. Mortgagor shall pay to Mortgagee a reasonable service charge and such title insurance premiums and attorneys' fees (including those of in-house staff) as may be incurred by Mongagee for any action described in this Paragraph 10 taken at the request of Mortgagor or its beneficiary or beneficiaties.

11. MORTGAGEE'S PERFORMANCE OF DEFAULTED ACTS. It case of default herein, Mortgagee may, but need not, make any payment or perform any act herein required of Mongagor in any form and manner Mortgagee deems expedient, and may, but need not, make full or partial payments of principal or interest on prior encumbrances,

if any, and purchase, discharge, compromise, or settle any tax lien or assessment of other prior lien or title or claim thereof, or redeem from any tax sale or forfeiture affecting the Premises or contest any tax or assessment or cure any default of any landlord in any lease of the Premises. All money paid for any of the purposes berein authorized and all expenses paid or incurred in connection therewith, including attorneys' fees, and any other funds advanced by Mortgagee in regard to protecting the Premises or the lien hereof, shall be so much additional much tendenses secured hereby, and shall become immediately due and payable without notice and with interest thereon at the late of interest set forth in the Note applicable to a period when a default exists thereunder. Inaction of Mortgagee shall never be considered as a waiver of any right accruing to it on account of any default on the part of Mortgagor.

13. ACCELERATION OF INDEBTEDNESS IN CASE OF DEFAULT. If (a) default occurs in the due and punctual payment of principal or interest on the Note, or any other payment due in accordance with the terms thereof; or (b) Mortgagor or any beneficiary thereof or any guarantor of the Note shall (i) file a petition for liquidation, reorganization, or adjustment of debt under Title 11 of the United States Code or any similar law, state or federal, whether now or hereafter existing, or (ii) file any answer admitting insolvency or inability to pay debts, or (iii) fail to obtain a vacation or stay of involuntary proceedings within ten days, as hereinafter provided; or (c) any order for relief of Mortgagor or any beneficiary thereof or any guarantor of the Note shall be entered in any case under Title 11 of the United States Code, or a trustee or a receiver shall be appointed for Mortgagor or for any beneficiary thereof or any guarantor of the Note, or for all or the major part of the property of Mortgagor or of any beneficiary thereof or of any guarantor of the Note in any voluntary or involuntary proceeding, or any court shall have taken jurisdiction of all or the major part of the property of Mortgagor or of any beneficiary thereof or of any guarantor of the Note in any voluntary or involuntary proceedings for the reorganization, dissolution, liquidation, adjustment of debt, or winding up of Mor.goor or of any beneficiary thereof or of any guarantor of the Note and such trustee or receiver shall not be discharged or such jurisdiction not be relinquished or vacated or stayed on appeal or otherwise stayed within ten days; or (d) Mortgogor or any beneficiary thereof or any guarantor of the Note secured hereby shall make an assignment for the benefit of creditors, or shall admit in writing its inability to pay its debts generally as they become due, or shall consent to the appointment of a receiver or trustee or liquidator of all or any major part of its property; (e) default shall occur in the due observance or performance of any other covenant, agreement, or condition contained in this Mortgage and required to be kept or performed or observed by Mortgagor or its beneficiary; (f) default shall

In the event the Mortgage is foreclosed, or Mortgagor tender; a deed in lieu of foreclosure, Mortgagor shall deliver the Premises to Mortgagee free of any and all Hazardous Naturials, so that the condition of the Premises shall conform with all applicable federal, state, or local laws, ordinance, rules, and regulations affecting the Premises. For purposes of this Paragraph 31, "Hazardous Materials" includes, with jut limitation, any flammable explosives, radioactive materials, hazardous materials, hazardous wastes, hazardous, regulated toxic substances, or related materials defined in the Comprehensive Environmental Response, Compensation, and Liability Act of 1980, as amended (42 U.S.C. §9601, et seq.), the Hazardous Materials Transportation Act, as aniended (49 U.S.C. §1801, et seq.), the Resource Conservation and Recovery Act, as amended (42 U.S.C. §6901, et seq.), and the regulations adopted and publications promulgated pursuant thereto, or any other federal, state, or local invironmental law, ordinance, rule, or regulation. Mortgagor shall secure all permits and approvals and file all notifications required under state and local laws, ordinances, and regulations prior to undertaking asbestos abatement activities. The provisions of this Paragraph 31 shall be in addition to any and all other obligations and liabilities Mortgago, near have to Mortgagee at common law and shall survive the transactions contemplated herein.

- 32. REVOLVING CREDIT. In the event that this Mortgage secures a revolving credit note, this Mortgage shall secure not only the existing indebtedness, but also such future advances, whether they are obligatory or to be made at the option of the Mortgage or otherwise, as are made within 20 years from the date hereof, to one same extent as if such future advances were made on the date of execution of this Mortgage, although there may one advance made at the time of execution of this Mortgage, and although there may be no indebtedness outstanding, at the time any advance is made. The total amount of indebtedness that is secured hereby may increase or decrease from time to time, but the total unpaid balance so secured at any one time shall not exceed the maximum principal amount of the Note, plus interest thereon, and any disbursements made for the payment of taxes, special assessments, or insurance on the Premises, with interest on such disbursements.
- 33. EXCULPATORY. In the event the Mortgagor executing this Mortgage is an Illinois land trust, this Mortgage is executed by Mortgagor not personally, but as Trustee aforesaid in the exercise of the power and authority conferred on and vested in it; as such Trustee, and Mortgagor hereby warrants that it possesses full power and authority to execute this instrument, and it is expressly understood and agreed that nothing contained herein or in the Note shall be construed as creating any liability on Mortgagor personally to pay the Note or any interest, late charge, or premium that may accrue thereon, or any Indebtedness secured by this Mortgage, or to perform any covenant, either express or
