MODIFICATION OF MORTGAGE

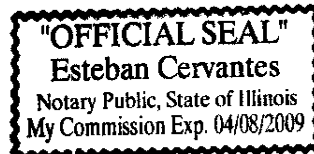

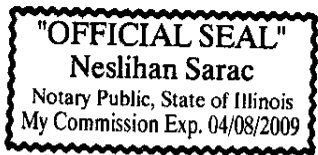
