I, ANTHONY J. SMIERCIAK AN ILLINOIS PROFESSIONAL LAND SURVEYOR, DO HEREBY CERTIFY THAT I AM THE SURVEYOR WHO HAS PREPARED THE PLAT TITLED KLAUS' RESUBDIVISION OF LOT 1 IN MIEDEMA'S SUBDIVISION, BEING A SUBDIVISION OF PART OF THE WEST HALF OF THE NORTHEAST QUARTER OF SECTION 36, TOWNSHIP 36 NORTH, RANGE 13 EAST OF THE THIRD PRINCIPAL MERIDIAN AS RECORDED DECEMBER 23, 2004 BY DOCUMENT NO. 0435839052 ALL IN COOK COUNTY, ILLINOIS. I FURTHER CERTIFY THAT SAID PLAT IS HEREBY CORRECTED AS FOLLOWS:

- 1) THE LINE BETWEEN LOTS 1 AND 2 IN THE AFORESAID KLAUS' RESUBDIVISION IS CORRECTED AS FOLLOWS: BEGINNING AT A POINT ON THE SOUTHWESTERLY LINE OF LOT 1 IN THE AFORESAID KLAUS' RESUBDIVISION, SAID POINT BEING 3.66 FEET NORTHWESTERLY OF THE SOUTHWEST CORNER OF LOT 1 IN THE AFORESAID KLAUS' RESUBDIVISION; THENCE EAST ON A LINE PARALLEL WITH THE SOUTH LINE OF LOT 1 IN THE AFORESAID KLAUS' RESUBDIVISION A DISTANCE OF 119.30 FEET TO A POINT OF INTERSECTION AND TERMINATION ON THE EASTERLY LINE OF LOT 1 IN THE AFORESAID KLAUS' RESUBDIVISION, SAID POINT OF TERMINATION BEING AN ARC MEASUREMENT OF 3.35 FEET NORTHERLY OF THE SOUTHEAST CORNER OF LOT 1 IN THE AFORESAID KLAUS' RESUBDIVISION AS MEASURED ON A LINE WITH 190.00 FOOT RADIUS.


