
NOW COMES the affiant, Tiffany Lynne Miles, being first duly sworn on oath and states:

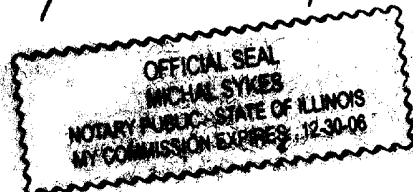

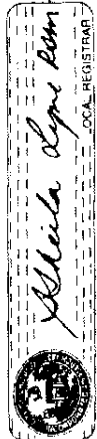
