## MODIFICATION OF MORTGAGE



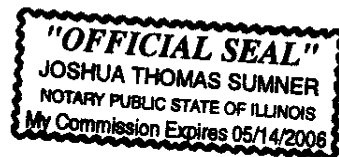
