LOT LEASE ASSIGNMENT

THIS LOT LEASE ASSIGNMENT is made as of the 31st day of January, 2006, by and between JOHN J. and JACQUELINE VASEY (herein "Assignor") and JOSEPH G. and DIAN E. SOLARI (herein "Assignee").

RECITALS

- A. Assignor or Assignor's predecessor in interest, as Tenant, and the Chicago Dock and Canal Trust. an Illinois business trust (herein "Landlord"), as Landlord, previously entered into a Residential Lot Lease dated as of February 19, 1997 and recorded in the Office of the Cook County Recorder of Deeds on February 28, 1977, as Document No. 97140720 (herein the "Lot Lease"), by which Landlord demised to Tenant or Tenant's predecessor in interest that certain parcel of land (herein the "Lot") legally described on Exhibit A attached hereto.
