TO HAVE AND TO HOLD the real estate with its appurtenances upon the trusts and for the uses and purposes herein and in the trust agreement set forth. This deed is made subject to the lien of every trust deed or mortgage (if any there be) of record in said county given to secure the payment of money, and remaining unreleased at the date of the delivery bereof.

As it would be lawful for any person owning the title to the real estate to deal with it, whether similar to or different from the vary above specified and at any time or times hereafter.
