MEMORANDUM OF LICENSE

This Memorandum of Site License Agreement is entered into this 29th day of November, 2005 ("SLA Effective Date") between New Cingular Wireless PCS, LLC, a Delaware limited liability company, with offices at 6100 Atlantic Boulevard, Norcross, Georgia, 30071, hereinafter designated as LICENSOR and VoiceStream GSM I Operating Company, LLC, with offices at 8550 W. Bryn Mawr, Chicago, Illinois, 60631, hereinafter designated as LICENSEE.

1. LICENSOR and LICENSEE entered into a Site License Agreement ("SLA") on the 29th day of November, 2005, for the purpose of installing, operating and maintaining a radio communications facility and other improvements. All of the foregoing are set forth in the Site License Agreement.
2. The term of the SLA is for five (5) years commencing on 11/29, 2005 and ending on 11/28/2010, with four (4) successive five (5) year options to renew. If all options to renew are exercised, the term of this SLA will expire twenty-five (25) years after the SLA Effective Date (as defined in the SLA).
3. The Land is described in Attachment 1 annexed hereto.
4. The original copy of this SLA is held at the LICENSOR's and LICENSEE's addresses set forth above.

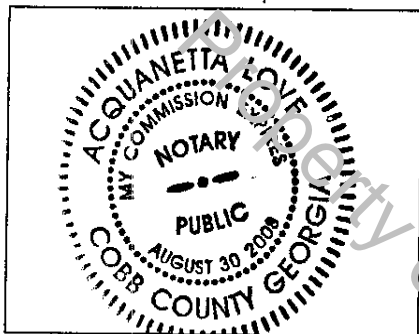

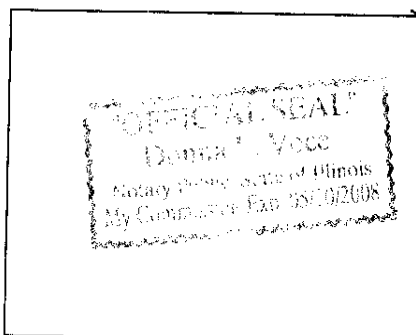
