On or about February 7, 2005, Claimant and Owner entered into a series of contractual arrangements wherein Claimant agreed to gut and rehab the Premises, including the removal of the existing roof and other elements of the Premises and the installation of a new roof, new siding, gutters, windows, floors, furnace, water heater, cabinets, and all related electrical and piping materials and appliances on Owner's behalf for the sum of \$150,000.00. The aforesaid contractual arrangements, as amended from time to time, are herein collectively referred to as the "Contracts"
- 3. Claimant has furnished substantial demolition and construction labor, materials, appliances and related parts and services at the Premises pursuant to the Contracts, all of which were performed with the consent, authorization and/or knowing permission of Owner.

4. The last day Claimant furnished labor or materials in connection with the Premises was on or about February 10, 2006. Based upon Owner's breaches of the Contract, including its willful failure to pay Claimant amounts due thereunder, Claimant is unable to complete its work.

5. After setoff for all partial payments by Owner and credits of account the balance due and owing to the Claimant for services furnished at the Premises pursuant to the Contracts is \$150,000.00. Claimant hereby claims a lien on the Premises in the sum of \$150,000.00, which represents the value of the work done at the Premises through February 10, 2005 for which payment has not been received, plus interest, attorneys' fees, and costs.
