

Legal Description

Block 1 in Cityfront Center, being a resubdivision in the North fraction of Section 10, Township 39 North, Range 14 East of the Third Principal Meridian, in Cook County, Illinois.

Also known as:

PARCEL 1:

That part of Plock 1 in Cityfront Center, being a resubdivision in the North fraction of Section 10, Township 39 North, Range 14 East of the Third Principal Meridian, described as follows:

Beginning at the Northcast corner of said Block 1; thence South along the East line of said Block 1, a distance of 125.106 feet to a point of curve; thence Southerly along the Easterly line of said Block 1. Leting the arc of a circle tangent to the last described line convex to the East and having a ratios of 2809.79 feet, an arc distance of 92.822 feet to the Southeast corner of said Block 1; thence West along the South line of said Block 1, a distance of 426.334 feet; thence North along a line perpendicular to said South line of said Block 1, a distance of 99.948 feet to 2 corner in said Block 1; thence North along a West line of said Block 1, a distance of 117.947 feet to the Northwest corner of said Block 1; thence East along the North line of said Block 1, a distance of 428.054 feet to the point of beginning, in Cook County, Illinois.

PARCEL 2:

That part of Block 1 in Cityfront Center, being a resubdivision in the North fraction of Section 10, Township 39 North, Range 14 East of the Third Principal Meridian, described as follows:

Beginning at the Southwest corner of said Block 1; thence North along the West line of said Block 1, a distance of 99.944 feet to a Northwest corner of said Block 1, thence East along a North line of said Block, being the South line of a public alley, a distance of 150.00 feet to a corner of said Block 1; thence South along a line perpendicular to the South line of said Block 1 at a point 150.164 feet East, as measured along said South line, from the Southwest corner of said Block 1, a distance of 99.948 feet to the South line of said Block 1; thence West along the South line of said Block 1, a distance of 150.164 feet to the point of beginning, in Cook County, Illinois.
