SECTION FOUR: That the approval of the preliminary plat of subdivision granted in SECTION ONE of this ordinance authorizes the submission of a final plat for the proposed subdivision and detailed plans and specifications for the public improvements therein. The preliminary approval shall be effective for a period no longer than 12 worths, unless extended by the President and Board of Trustees during that period.
