I, WAYNE FRANKLIN, under oath, state and depose as follows:

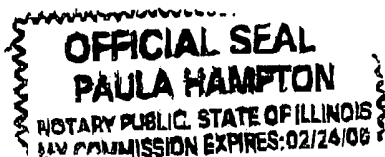
- 1. I am of legal age and the son of Sallie P. Moten, deceased.
