 - To employ attorneys, auditors, depositaries and agents, with or without (e) discretionary powers; to exercise in person or by proxy all voting and other rights with respect to stocks or other securities; and to keep any property in bearer form or in the name of an Executor or a nominee, with or without disclosure of any fiduciary relationship
