time he or she will spend testifying at any such deposition. Unless the physician
was retained by a party for the purpose of rendering an opinion at trial, or unless
otherwise ordered by the Court, the fee shall be paid by the party at whose instance
the deposition is taken. Supreme Court Rule 203. Unless otherwise agreed,
depositions shall be taken in the county in which the deponent resides or is employed
or transacts business in person, or, in the case of a plaintiff-deponent, in the county
in which the action is pending. However, the court, in its discretion, may order a
party or a person who is currently an officer, director, or employee of a party to
appear at a designated place in this State or elsewhere for the purpose of having the
deposition taken. The order designating the place of deposition may impose any
terms and conditions that are just, including payment of reasonable expenses.
