- 3. That Air Dynamics entered into a Contract with Gatwood, whereby Claimant agreed to furnish Crane / Operator Rental, (related materials, apparatus, and labor) to Air Dynamics in exchange for payment in the original Contract amount of Ten Thousand, Twenty-Five Dollars & 00/100, (\$10,025.00).
- 4. That the Contract was entered into between Air Dynamics and Claimant with the full knowledge and consent of Owner(s). Alternatively, the Owner(s) specifically authorized Air Dynamics to enter into Contracts for, and in said improvement of the Real Estate. Alternatively the Owner(s) did knowingly permit Air Dynamics to enter into Contracts, for and in said improvement of the Real Estate.

At the special instance ard request of Air Dynamics and with the full knowledge and express consent or acquiescence of Owner(s), Claim in furnished extra and additional materials and extra and additional labor on the Real Estate to the value of \$ .00 Claimant completed providing the additional materials and labor at various times.
- 6. That on December 14, 2005 Claimant completed and delivered, substantially all work and materials required to be performed under the Contract.
  - 7. That Air Dynamics is entitled to credits for payments in the amount of \$4,315.00.
- 8. As of the date hereof, there is due, unpaid and owing to Claimant, after allowing credits for payments by Air Dynamics, the balance of Five Thousand, Seven-Hundred and Ten Dollars & 00/100, (\$5,710.00), for which with interest, Claimant claims a lien on the Real Estate and on the monies or other considerations due, or to become due from Owner(s), to Air Dynamics Inc.
