### CONSENT JUDGMENT FOR ATTORNEYS' FEES




# UNOFFICIAL COPY

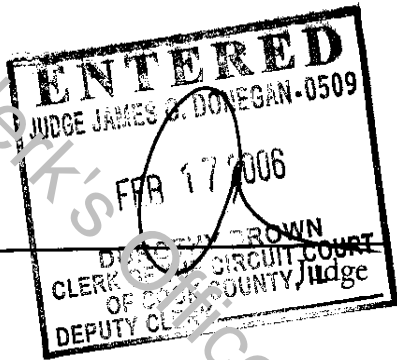
