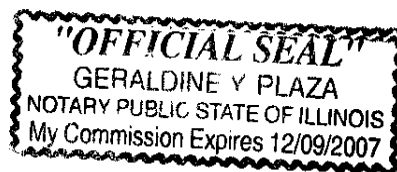

## Legal Description

### Parcel 1:

Unit 1E in Four Thirty Four West Aldine Avenue Condominium, as delineated on a survey of the following described real estate:
