The responsibility, power, and authority granted to my Attorneys In Fact shall not be affected by my subsequent disability or incompetence, and shall be durable in nature.



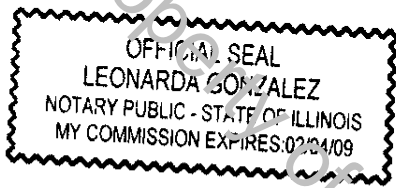
